Dear Sir.

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1(a) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 15.02.2024 at 13:15 Hrs. I Sri Subhajit Pratihar, DE & SM Purulia CCC WBSEDCL along with, Chinmoy Maity (JE (E) attached to Purulia CCC), Anurag Pandey (OE attached to Purulia CCC), Sanjoy Kumar Mahato (Sr TSH attached to Purulia CCC) went to make an inspection to workout upon a source information regarding theft of electricity for at the domestic premises of Nargis Khatun, wife of Maniur Rahaman, resident of J.K.College Road, Rani bandh ,Purulia(T) Thana , Dist Purulia by serving one entry notice which was refused to signed by the consumer .

During the time of inspection at the premises 1 nos of electricity meter was found having serial no T03038918 (Consumer id 203165872, Consumer Name- Nargis Khatun).

It was observed that consumer Nargis Khatun has made unauthorized use of electricity under section 135 1(a) by tapping the service wire of the license and connecting it directly to the wiring to run domestic appliances and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Pump 1 nos 746 watt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service connections in the premises from pole with the help of LT Mobile Van Team and removed & seized 3 feet service cable black color, taped, with bypass arraignment of black and blur color single phase cable & prepared seizure list and other inspection related documents which was refused to be signed by the consumer, however consumer signed the entry notice while leaving the premises.

The inspection team left the premises at about 13.45 Hrs on 15TH FEB 2024.

The accused committed theft of electricity U/S 135 1(a) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
