Sir,

In producing herewith the arrested accused person namely Fulchand Mahato (33Yrs) S/o- Late Arjun Mahato of Vill- Gopalpur, PS- Purulia (M), Dist- Purulia and seized articles 18 (Eighteen) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (11.02.2024) while I, SI Bangshidhar Mukherjee along with force (i) C/- 851Amrit Banerjee& (ii) HG/- 1576 Shaktipada Mahato all of Purulia (M) PS vide GDE No- 580 Dtd. 11.02.2024 are performing mobile duty at about 17.15 hrs I received secret information regarding an illegal possession of a huge quantity of liquors in a shop of Gopalpur more. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot at about at about 17.55 hrs, situated at Gopalpur moreunder Purulia (M) PS. After arriving at the spot and as per your instruction we conducted a raid in the shop. During the raid some people fled away and apprehended one person. On being asked he disclosed his identity as Fulchand Mahato (33Yrs) S/o- Late Arjun Mahato of Vill- Gopalpur, PS- Purulia (M), Dist-Purulia. On being interrogated he confessed that he procured and stocks illegal liquors for selling illegally in his shop. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 18 (Eighteen) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each. In which 01 sealed bottle taken as samples from 'DIL KHUSH'. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 18.05 hrs &18.35 hrs.

Accordingly, I arrested the above noted accused person at 18.45 hrs after maintaining all formalities regarding arrest after issuing a Check List. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you that kindly take lawful action against the arrested accused person namely Fulchand Mahato (33Yrs) S/o- Late Arjun Mahato of Vill- Gopalpur, PS- Purulia (M), Dist-Purulia under proper section of Law.
