Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Joydeb Majhi (47 Yrs) S/o- Lt. Haren Majhi of Vill+PO- Manguria, PS- Tamna, Dist- Purulia and seized articles 19 (Nineteen) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (18.02.2024) while I, SI Abhijit Singha along with force (i) C/699 Biswajit Banerjee (ii) C/321 Tulsidas Roy both of Purulia (M) PS vide GDE No- 993 Dtd. 18.02.2024 were performing Special mobile duty, at about 17.05 hrs, I received a secret tip off an illegal possession of a huge quantity of liquors at a Hotel near Raibaghini on the side of Ranchi road under Purulia (M) PS. Subsequently, I informed the matter to you and as per your direction, I along with force rushed to the spot i.e. Hotel near Raibaghini on the side of Ranchi road under Purulia (M) PS, and after arriving at the spot we conducted raid in the Hotel of Jaydeb Majhi situated at Hotel near Raibaghini on the side of Ranchi road under this PS. During the raid some people managed to escape and detained one person. On being asked the detained person disclosed his identity as Joydeb Majhi (47 Yrs) S/o- Lt. Haren Majhi of Vill-Manguria, PS- Tamna, Dist- Purulia. On being interrogated he confessed that he procured and stocked the illegal liquors in his Hotel for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 19 (Nineteen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle was taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 18.25 & 18.35 hrs.

Accordingly, I arrested the involved accused person namely Joydeb Majhi (47 Yrs) S/o- Lt. Haren Majhi of Vill- Manguria, PS- Tamna, Dist- Purulia at 18.45 hrs after maintaining all formalities regarding arrest and issued Check List. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Joydeb Majhi (47 Yrs) S/o- Lt. Haren Majhi of Vill- Manguria, PS- Tamna, Dist- Purulia under proper section Lacine an 18 of 24 at 19 is by and Scale projection of 18 of 24 of A(c) of Belight Excine but 1909, of Law.
