Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Tapan Roy (52 Yrs) S/o- Lt. Anil Roy of Vill- Nadiara, PS- Purulia (M), Dist- Purulia and seized articles 17 (Seventeen) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (18.02.2024) while I, SI Mekdam Sabab along with force (i) C/248 Arabinda Roy (ii) C/768 Ajit Kumar Murmu both of Purulia (M) PS vide GDE No- 988 Dtd. 18.02.2024 were performing evening night mobile duty, at about 19.05 hrs, I received a secret tip off an illegal possession of a huge quantity of liquors at Nadiara morh. Subsequently, I informed the matter to you and as per your direction, I along with force rushed to the spot i.e. Nadiara morh, and after arriving at the spot we conducted raid in the Tea Shop of Tapan Roy situated at Nadiara morh under this PS. During the raid some people managed to escape and detained one person. On being asked the detained person disclosed his identity as Tapan Roy (52 Yrs) S/o- Lt. Anil Roy of Vill- Nadiara, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the illegal liquors in his Tea Shop for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 17 (Seventeen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle were taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 20.25 & 20.45 hrs.

Accordingly, I arrested the involved accused person namely Tapan Roy (52 Yrs) S/o- Lt. Anil Roy of Vill- Nadiara, PS- Purulia (M), Dist- Purulia at 20.55 hrs after maintaining all formalities regarding arrest and issued Check List. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Tapan Roy (52 Yrs) S/o- Lt. Anil Roy of Vill- Nadiara, PS- Purulia (M), Dist- Purulia under proper section of Law.
