Sub: Prayer for lodging FIR.

Sir,

In producing herewith one arrested accused person namely Prasanta Duari (30 Yrs) S/o- Ambuja Duari of Vill- Ramdih, PS- Purulia (M), Dist- Purulia and seized articles 22 (Twenty Two) numbers of sealed bottles of DIL KHUSH C/S, each containing 600 ml along with seizure list.

I beg to state that today (19.02.2024) at 18.35 hrs I, SI Abhijit Singha of Purulia (M) PS received a secret tip off an illegal possession of a huge quantity of liquors in a Hotel under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force (i) C/692 Ukil Ch. Mahato (ii) C/624 Pradip Chakraborty both of Purulia (M) PS vide GDE No- 1062 Dtd. 19.02.2024 rushed to the spot i.e. a Line Hotel of Jorabandh area near Bhangra village at 19.25 hrs. After arriving at that spot and as per your instruction we are conducted a raid in the Line Hotel situated near Bhangra village under this PS. During the raid some people managed to escape and detained one person. On being asked, the detained person disclosed his identity as Prasanta Duari (30 Yrs) S/o-Ambuja Duari of Vill- Ramdih, PS- Purulia (M), Dist- Purulia. On being interrogated the detained person confessed that he procured and stocked the said illegal liquors in his Line Hotel for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 22 (Twenty Two) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle was taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 19:45 & 19:55 hrs.

Accordingly, I arrested the involved accused person namely Prasanta Duari (30 Yrs) S/o- Ambuja Duari of Vill- Ramdih, PS- Purulia (M), Dist- Purulia at 20.05 hrs after maintaining all formalities regarding arrest, issued Check List. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Prasanta Duari (30 Yrs) S/o- Ambuja Duari of Vill- Ramdih, PS- Purulia (M), Dist- Purulia under proper section of Law.
