Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Sayan Bauri (25 Yrs) S/o- Aditya Bauri of Vill- Chharrah Dhundulpara, PS- Purulia (M), Dist- Purulia and seized articles 21 (Twenty One) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (20.02.2024) during mobile duty at about 17.25 hrs I, SI Mekdam Sabab of Purulia (M) PS received a secret tip off an illegal possession of a huge quantity of liquors in a Tea Stall. Accordingly, I informed the matter to you and as per your direction myself along with force (i) C/1350 Subodh Kr. Bauri (ii) NVF- 187 Upinath Tudu both of Purulia (M) PS vide GDE No- 1124 Dtd. 20.02.2024 rushed to the spot i.e. Suribandh area at 17.55 hrs. After arriving at that spot and as per your instruction we conducted a raid in a Tea Stall situated at Suribandh area near Chharra village under Purulia (M) PS. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Sayan Bauri (25 Yrs) S/o- Aditya Bauri of Vill- Chharrah Dhundulpara, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his poultry shop for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized 21 (Twenty One) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle was taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 18.25 & 18.35 hrs.

Accordingly, I arrested the involved accused person namely Sayan Bauri (25 Yrs) S/o- Aditya Bauri of Vill- Chharrah Dhundulpara, PS- Purulia (M), Dist- Purulia at 19.15 hrs after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Sayan Bauri (25 Yrs) S/o- Aditya Bauri of Vill- Chharrah Dhundulpara, PS- Purulia (M), Dist- Purulia under proper section of Law.
