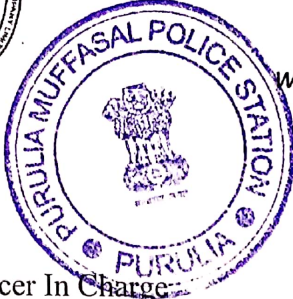

I Sri Prashant Kishor, S/O - Kishori Prasad, Station Manager of Chakda CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Dhananjay Pandey S/O Rakhyakar Pandey of Vill - Imondih PS- Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 21.02.2024 I, Prashant Kishor (DE&SM), along with Sri Indrajit Sinha JE (GR-I), & Sri Shyamapada Mahato (Sr TSH) of Chakda CCC, WBSEDCL conducted a raid programme at village Imondih under Purulia(M) P.S. When our team at about 12:25:00 PM. entered to the Domestic premises of Dhananjay Pandey, we found that he was enjoying electricity dishonestly by means of Direct hooking from nearest LT OH Line and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized, and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 12:35:00 PM. after completion of inspection & necessary formalities.

Dhananjay Pandey S/O Rakhyakar Pandey of Vill - Imondih PS- Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity(Amendment) Act-2007.
