



3) _____That Grand-daughter of complainant after born suffering various ailments and at that time wife of Naba Kishore abused fibthy languages and called complainant





by saying "witch ". There after complainant reported the matter to Purulia(M) Police Station on 22.9.2023 where the matter was compromised between the parties, and since then the wife of Naba Kishore (Babita Gorain) reside her Father's house at Village- Mahara under Manba-zar Police Station.


That on the date of incident i.e. 30.12.2023

(13 Pouse) saturday at about 11.00 a.m. to 11.30 a.m. app-rox all the accused persons forming and unlawful assembly
with various weapon criminally tresspassed in to the house
of the complainant, when complainant and her husband, Deor
Ranjit Gorain, eldest Son Naba Kishore Gorain was not
present at home. The accused persons abused filthy langua-ges to youngest son of complainant and her father-in-law
Mother-in-law, and there was hot exchange of words among-est them.

Thereafter all the accused persons without any provocation assulted, those persons Chiranjit Gorain and father-in-law Mother-in-law for complaint by fist and blows. Then all the accused persons locked them in a room and snatch-ed the key of Godrej Almira and looted all the golden ornaments and silver ornaments and others house hold articles and put those articles in three bags, Thereafter the accused persons open the door and threaten them with dire consequence, thereafter the accused persons left place by vehicle when the local people came.

5) ____ That after incident complainant reported the matter to I.C. Purulia (M) Police Station on 17.1.2024





Though the matter was reported at Purulia (M)Police Station that legal main action would be taken in time but in vain. Thereafter complainant report the matter to the superintendent of Police on 19.1.2024 but with same fact.



- 6) ____ That the complainant under the assurance of Police waited for action to be taken by them and that delay her caused.
- 7) ____ That the complainant is law abiding citizen respect the law and the Hon'ble Court.
- 8) _____ That complainant is very poor women and ailing persons and not in a position to conduct the case of her own apart from that police investingation in required for recovery of those acticles.
