Most respectfully begs to state:

1. That your petitioner is the legally married wife of the accused person and as there is some matrimonial dispute she use to live in her government railway quarter as there was some matrimonial dispute between her and the accused person.
2. That in April 2020, the petitioner was driven out from her matrimonial home with his minor son and since then she is residing at her government railway quarters with her son.
3. That for committing torture and offences your petitioner had already lodged a letter of complaint before Purulia Town P.S. which was registered as Purulia(T) P.S. Case No. 69/21, dated-10.05.20221, U/S-498A/323/325/506/34 I.P.C and section 3 and 4 of D.P. act.
4. That after lodging of this case the present accused became furious and occasionally used to came near the residence of the petitioner and used to abuse the petitioner and her son with filthy languages.
5. That on 23.12.2023 around 7 A.M. the accused suddenly entered into the quarters of the petitioner in intoxicated condition and started abusing her in filthy languages.
6. That when your petitioner raised protest the accused caught hold of the lock of hair of the petitioner and dashed her into the floor as a result of which one of her tooth get uprooted and started assaulting her on her various body parts with fists and blows.
7. That the accused person throttled the petitioner by holding her neck with an attempt to kill her and the petitioner somehow escaped from

the clutches of the accused person and came out of her house. The witnesses have seen the incident.

8. That the petitioner was treated by Dr. Suman De and as the petitioner was involved in her treatment she could not lodge any complaint before hand.
9. That the matter was reported to the officer-in-charge of Purulia(T) P.S. as well the S.P. Purulia on 28.12.2023 but no action has been taken.
10. That the case involves examination of witnesses, seizure of articles and medical report and accordingly a police probe is required.

It is, therefore, prayed that your Honour may graciously be pleased to direct the police of Purulia (Town) P.S. to treat this petition as a F. I. R. and to cause investigation in respect of the alleged incident.
