I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1(b) , 1(c) & 1(d) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 01.02.2024 at 17:08 Hrs. I Sri Subhajit Pratihar, DE & SM Purulia CCC WBSEDCL along with, Chinmoy Maity (JE (E) attached to Purulia CCC), Anurag Pandey (OE attached to Purulia CCC), Sanjoy Kumar Mahato (Sr TSH attached to Purulia CCC) went to make an inspection to workout upon a source information regarding theft of electricity at the premises of Tapos Mahato, Son of Late Biswanath Mahato, resident of Nimtar, Bhatbandh, Purulia (T) Thana, Dist Purulia.

During the time of inspection at the premises 3 nos of electricity meter was found having serial no T02437223, (Consumer id 202275392, Consumer Name- Tapos Mahato), serial no SE04490 and 4M383952.

It was observed that user Tapos Mahato has made unauthorized use of electricity under section 135 1(b), 1(c) & 1(d) by damaging the meter & inserting foreign material in meter serial no T02437223, which works as resistance to interfere with accurate or proper registration of electricity consumption and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using AC 2 nos 3600 watt ,Fan 5 nos (60 watt each) , Light 12 nos (15 watt each) , TV 1 nos 60 watt each, Fridge 200 watt , Pump 1 nos 750 watt , in his domestic premises as well as in commercial premises.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected all the 3(three) service lines (T02437223, SE04490 & 4M383952) in the premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of damaged energy meter bearing meter T02437223. Prepared seizure list and other related documents in front of the local witness and representative.

The inspection team left the premises at about 17:35 Hrs on 1st February 2024.

The accused committed theft of electricity U/S 135 1(b), 1(c) & 1(d) of the electricity Act 2003, Amendment of

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
