last 23 years that is his nephew used to stay with them in their house for the last 23 years. During that period of time the nephew of the complainant was in a relationship with a girl named Sayantika Dutta, d/o Raja Dutta of sabitri Mansion Sasadhar ganguly road near hanuman Mandir , Purulia.

2. That the nephew of the complainant namely Ayush Singh, s/o Tutul Singh was engaged with this above named girl namely Sayantika Dutta, d/o Raja Dutta from 20/6/2021. And their relationship was subsisting .
3. That although the nephew of the complainant one Ayush Singh was in the relationship with Sayantika Dutta but there were discordance and battle of wills within themselves in their relationship associated with stress and tensions in their relationship.
4. That the reason of such tightness was the difference of caste of both Ayush Singh and Sayantika Dutta.
5. The complainant and the other family members of the complainant convinced Ayush Singh to come out of this relationship to avoid social disturbance and unrest which is very natural in inter caste relationships. But due to immense threat and intimidation from the side of the said girl Sayantika Dutta , Ayush Singh was unable to come out of this relationship.
6. That the said girl Sayantika Dutta always used to give constant instigation , provocation , persuasion to Ayush Singh for ending his life if he is unable to proceed with the relationship with her . And after the phone call with Sayantika Dutta , the nephew of the complainant used to share about his mental distress regarding the conversation in the phone call made with Sayantika Dutta that is " if I don't talk to her frequently and keep relationship with her then I will have to end my life "
7. That the said girl Sayantika Dutta is studying in Bhubaneshwer and during this phase also she continued to provoke , insist Ayush Singh to commit suicide and created

immense mental pressure on him, harassing mentally was on its peak . The girl always wanted to keep Ayush under her thumb and Ayush was crushing himself in her provocation and instigation to commit suicide .

8. That the girl Sayantika succeeded in her mission when the Complainants nephew Ayush Singh committed suicide by hanging himself on 22/9/23 night . Not being able to tolerate the insult , disrespect , provocation of sayantika Dutta. Previously also Ayush Singh not being able to tolerate the immense mental stress from Sayantika Dutta tried to end his life .
9. That few days before this incident took place the complainants nephew namely Ayush Singh told to his mother that Sayantika dutta is trying to provoke him to end his life repeatedly and she is demanding money from Ayush . Previously in several other occasions Ayush lended her some amount of money as she demanded to calm her down and avoid unnecessary insult and humiliation . This was found from the account statement of Ayush Singh. In every occasions this girl Sayantika Dutta used to provoke , instigate Ayush in his phone calls, video chat, whatsapp chat etc.
10. That in the night of the incident also Sayantika Dutta provoked Ayush on the way to eternal peace that is heaven and sacrifice his life in the lap of death.
11. That for the purpose of investigation the complainant noted the contact number of Ayush singh , that is 8637313376 and Sayantika Dutta , that is 9907188135. And definitely these phone number will be able to solve the cause of the death of Ayush singh.
12. That the instagram account and facebook account of Ayush Singh was also handled by this girl Sayantika Dutta and had full control over it .
13. That after the death of Ayush Singh , Sayantika dutta confessed her guilt to the sister of the complainant who

was the mother of Ayush Singh on a phone call. And also told the mother of Ayush that, has she not instigated him that night of the incident Ayush would have been living today. But on the other hand she also threatened the mother of Ayush singh not to lodge any complaint against her . And for this reason on various occasions and from various phone numbers threatening call was coming to the mother of Ayush singh

14. That in this full incident the father of the girl Sayantika Dutta used to support her in all her steps.
15. That the complainant lodged this complaint to the concerned PS on 10/10/23 but the IC Purulia ( Town) PS did not take any action against the present accused person nor he lodged any FIR in respect of the said complaint , then on 28/12/23 the complainant further informed to the SP purulia but till date no action had been taken . So the defacto complainant preferred to file this petition before your honour u/s 156(3)CrPC

It is, therefore, most respectfully prayed that Your Honour may graciously be pleased to except this petition and sent this complaint to IC Purulia(Town) PS for lodging FIR and take necessary action in accordance with law
