I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1(b) & 1(d) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 23.02.2024 at 2.30 P.M. I Sri Chinmoy Maity, Station Manager Purulia CCC WBSEDCL along with Anurag Pandey (OE attached to Purulia CCC), Sanjoy Kumar Mahato (Sr TSH attached to Purulia CCC) along with L.T.Mobile Van went to make an inspection to workout upon a source information regarding theft of electricity at the premises of Sabina Khatoon, WIfe of Md Shakil, resident of Katin Para(Hargara Road), Purulia (T) Thana, Dist Purulia.

During the time of inspection at the premises 1 nos of electricity meter was found having serial no 0B4599751, (Consumer id 202636973, Consumer Name- Sabina Khatoon).

It was observed that user Sabina Khatoon has made unauthorized use of electricity under section 135 1(b) & 1(d) by tampering the energy meter serial no 0B4599751 of WBSEDCL, which works to, interfere with or bypass accurate or proper registration of electricity consumption and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Fan 3 nos (60 watt each), Light 3 nos (6 watt each), Water pump 373 watt each in his domestic premises.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service lines in the premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of tampered energy meter bearing meter 0B4599751. Prepared seizure list and other related documents in front of the local witness and representative.

The inspection team left the premises at about 02.15 P.M. on 23rd February 2024.

The accused committed theft of electricity U/S 135 1(b) & 1(d) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
