Sir,

I the undersigned would like to inform you that my father namely Chittaranjan Sen since deceased used to live with my mother namely Manika @ Monika Sen at Flat No. G-3, Hudco, P.O- Namopara, P.S- Purulia (T), Dist- Purulia and we were two brothers, but my elder brother died prior to the death of my father leaving behind his widow namely Shanta Sen and her daughter namely Asmita Sen as his surviving legal heirs. My father due to his old age suffering from various ailments since after COVID 19, and taking advantaged of his illness my nephew namely Asmita Sen, who used to reside in Mumbai, used to come Purulia on various occasion and she in collusion with her mother namely Shanta Sen and one of her inmate namely Rupes Tewari, by hatching a conspiracy with some others with some ulterior motive in order to hush up the money, valuable securities and properties somehow managed to opened joined account with my father, and by undue influence took all the pass book of my deceased father, entered her name as nominee of all the bank accounts, took all ATM Cards and withdrew lacks and lacks rupees on the plea of treatment of my father. It is pertinent to mentioned here that she also took advantages of the mental instability of my mother and took possession of entire gold ornaments of my wife and deed of the flat and other valuable articles from the clutches of my mother.

That my deceased father died on 02.01.2024 and after his shradh karma, it has come to learn me that From the joint account of my father and mother, said Ashmita withdraw a sum of Rs. 87,000/- from 03.01.2024 to 12.01.2024 and

presently the account balance is only 687.70. It also appear from the statement of joint account being No. 1426101014781, maintained at Canara Bank, she also withdraw and transfer near about 11,00,000/- (eleven Lakhs) and having come to learn when I asked her for furnished the accounts for the treatment of my father lastly on 24.01.2024, she suddenly become violent and started to abuse me in filthy languages and she along with Shanta Sen, Rupesh Tewari and some others started assaulted me and threaten me with dire consequences that if I adventures to lodged any complaint, then I will be murdered.

That seeing no other alternative I being a physically permanent 80% disabled person have submitted a letter to the Post Master, Nilkuthidanga Post office with a request to make the account being No. 020073166312 as non-operative in order to prevent from misappropriation of the money of my mother from the hands of Ashmita, Shanta and Rupesh.

Sir under the circumstances it appears that the above named person in collusion with each other by hatching a conspiracy, taking advantaged of death of my father and mental instability of my mother misappropriated huge amount causing wrongful gain for themselves.

In this regard you are requested to take necessary action against the wrongdoers.
