Sir,

In producing herewith accused Mantu Shaw (49 years) S/o Late Biswanath Shaw of Bediagara, Raghunathpur Ward No- 05, P.O+P.S-Raghunathpur, Dist -Purulia and seized (i) 08(Eight) Bottles liquor each bottle containing 600 ML (MRP- 55/-) styled as "DIL Khush" (ii) 01 (One) bottle liquor containing 600 ML (MRP- 155/-) styled as "CAPTAIN" (iii) 30 (Thirty) Pieces Plastic Glass, (iv) 04(Four) Pieces Steel Glass under proper Seizure List duly signed by the witnesses. I beg to submit that today i.e. on 09.02.2024 at 20:25 hrs while myself along with force were performing evening mobile duty at P.S area, vide Patrasayer P.S C.C. No.- 435/24 Dated- 09.02.2024 and received a source information that one Mantu Shaw (49 years) S/o Late Biswanath Shaw of Bediagara, Raghunathpur Ward No- 05, P.O+P.S-Raghunathpur Dist -Purulia is selling liquor in exchange of money at Petaro Para behind the Netaji Club, Ward No-05, P.O+P.S-Raghunathpur, Dist -Purulia, (W.B). After receiving this information I informed the matter to IC Raghunathpur PS and as per his direction I along with C/ 716 Achinta Majee and NVF-675 Sunil Tantubai left for said place to work out the source information. On reaching there at 20:55 hrs, identified by source I found that said Mantu Shaw was selling liquor in exchange of money, I then asked him to produce valid license or valid documents for selling the liquor but he failed to produce any valid license or documents before me and failed to give any satisfactory answer regarding the selling of liquor. On being further asked, he stated that he was selling liquor in exchange of money illegally since long. As such at 21:05 hrs to 21:20 hrs I seized the following articles from his possession with proper seizure list duly signed by him and witnesses. And at 21:25 hrs, I arrested him issuing Memo of arrest and obtaining all the formalities of NHRC. I also prepared label of seized articles:-

Seized Articles

(i) 08(Eight) Bottles liquor each bottle containing 600 ML (MRP- 55/-) styled as "DIL KHUSH" (ii) 01 (One) bottle liquor containing 600 ML (MRP- 155/-) styled as "CAPTAIN" (iii) 30 (Thirty) Pieces Plastic Glass, (iv) 04(Four) Pieces Steel Glass.

So I pray that a specific case may kindly be started against said Mantu Shaw (49 years) S/o Late Biswanath Shaw of Bediagara, Raghunathpur Ward No- 05, P.O+P.S-Raghunathpur, Dist -Purulia, under section 46A( C) of Bengal Excise Act 1909 and to arrange for its investigation.
