



Sir,

In producing herewith one arrested accused person named as Baidyanath Ojha (26 Yrs) S/O – Satyaban Ojha of Vill. - Deoli, PS-Santaldih Dist- Purulia along with seizure – list and seized items as described below, I beg to state that on 09.02.2024 at about 21.05 hrs, while performing evening mobile duty, I received a source information to the effect that the foreign liquor has been kept at Paharigora More under this PS in the shop of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and this refers to Santaldih PS GDE no. 378 dtd. – 09.02.2024 and as per order of I.C Santaldih P.S. I along with force left for Paharigora more to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the shop of Baidyanath Ojha at Paharigora more, P.S. Santaldih at about 21.25 hours. Seeing police party some unknown persons in front of the shop of Baidyanath Ojha were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the foreign liquor for selling and he was the owner of the said shop. However, I along with said accused started a search inside the shop of Baidyanath Ojha and found the following item in the said shop -

- 07 bottles of 375 ML different brand of foreign liquor i.e. McDowell No. 1 01 bottle, Imperial Blue 01, Officer's Choice - 01 bottle, Iconic White - 01 bottle, Sterling Reserve - 01 bottle, Old Monk - 01 bottle & McDowell 1 no. XXX Rum - 01 bottle
 - From which randomly One bottle of 375 ML has been taken as sample i.e. McDowell No. 1.
- 2) 07 bottles of 180 ML different brand of foreign liquor i.e. Officer's Choice 01 bottle, Old Monk 02 bottles, Blenders Pride 01 bottle, Sterling Reserve 02 bottles, & Royal Stag 01 bottle From which randomly One bottle of 180 ML has been taken as sample i.e. Old Monk.
- 3) 07 bottles Country Spirit style as Dilkhus each bottle containing 600 ML From which 01 bottle taken as sample.
- 4) 03 bottles Country Spirit style as Dilkhus each bottle containing 375 ML From which 01 bottle taken as sample

I interrogated him about the purpose of the stocking and possessing such foreign liquor. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 21.45 hrs and 22.05 hrs & took up one bottle randomly from different type of foreign liquor of 375 ML, one bottle randomly from different type of foreign liquor of 180 ML, One bottle C.S. (Dikhus) 600 ML & One bottle C.S. (Dilkhus) 375 ML as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the foreign liquor & Country Spirit liquor illegally without any valid papers in his shop has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 22.10 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Baidyanath Ojha (26 Yrs) S/O – Satyaban Ojha of Vill. - Deoli, PS-Santaldih Dist- Purulia.
