Sub : Prayer for lodging FIR against accused (i) Anil Gorain (27Y), S/O Dhiren Gorain & (ii) Naran Gorain (39Y), S/O Ananda Gorain both of Vill. - Kanki Basti, PS-Santaldih Dist- Purulia.

Sir,

In producing herewith 02 (two) arrested accused persons named as (i) Anil Gorain (27Y), S/O Dhiren Gorain & (ii) Naran Gorain (39Y), S/O Ananda Gorain both of Vill. - Kanki Basti, PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 15.02.2024, I along with force were performing STPS night mobile duty in PS area vide Santaldih P.S. GDE No- 606 Dated- 15/02/2024 in c/w Santaldih PS CC No- 440/24 Dated- 15/02/2024. During my STPS night mobile patrolling duty, at about 23.25 hrs when I along with force arrived near STPS 1no gate under this PS we saw 02 (two) persons carrying bag moving here and there suspiciously. After seeing the police vehicle both of them tried to flee away and we could able to detain them and asked about their identity. They disclosed their name and identity i.e. (i) Anil Gorain (27Y), S/O Dhiren Gorain & (ii) Naran Gorain (39Y), S/O Ananda Gorain both of Vill. - Kanki Basti, PS-Santaldih Dist- Purulia but they made in-coherent statement in respect of their suspicious movement and carrying items in their bags. Subsequently, we search their bags and found (i) 20 bottles Country spirit (**Dilkhus**) each bottle containing 600 ML in a plastic bag from the possession of said Anil Gorain & (ii) 15 bottles Country spirit (**Dilkhus**) each bottle containing 600 ML & 03 bottles Kingfisher strong Beer each bottle containing 650 ML in a plastic bag from the procession of said Naran Gorain.

I interrogated them about the purpose of the possessing such liquor. They replied it was the business of them. On repeated question they told that they sell the said liquor to the local people for their wrongful gain. However they could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 00.05 hrs and 00.15 hrs & took up two bottles country spirit (**Dilkhus**) and one bottle kingfisher strong Beer as samples, labeled and sealed accordingly.


Since the allegation against them of possessing, as well as selling the foreign liquor & Country Spirit liquor illegally without any valid papers, prima-facie has been made out and for the interest of proper investigation, I arrested the above accused persons accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused persons namely (i) Anil Gorain (27Y), S/O Dhiren Gorain & (ii) Naran Gorain (39Y), S/O Ananda Gorain both of Vill. - Kanki Basti, PS-Santaldih Dist- Purulia.
