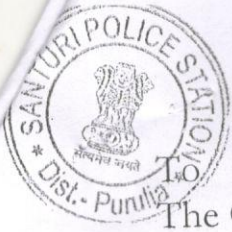

**Sub:** Complaint against Simanta Dasgupta @ Fucha (30 Yrs) S/O-Bipin Dasgupta of Vill-Sunuri Majhpara, PS-Santuri, Dist-Purulia to start a cog case U/S- 46AA B.E. Act 1909.

Respected Sir,

In producing herewith arrested accused person namely Simanta Dasgupta @ Fucha (30 Yrs) S/O-Bipin Dasgupta of Vill-Sunuri Majhpara, PS-Santuri, Dist-Purulia along with seized I.D. Liquor approx 12 Liters in a plastic container and "NISADAL" approx 500 grams, as per seizure list, all duly labeled and some portion of each articles kept as sample. I, ASI Jhantu Dalal of Santuri PS do hereby lodge a complaint that on 03.02.24 at 17:05 hrs received source information that, the above noted accused person was unlawfully selling I.D. Liquor and mixing intoxicating drug to that liquor at dwelling house of Simanta Dasgupta @ Fucha at Sunuri Majhpara village. Accordingly I informed the fact to O/C, Santuri PS and as per direction myself along with force with Govt. Vehicle had been at the above noted place and held a raid in the said house.

Reached at the house of the accused person at village Sunuri Majhpara at 17:45 hrs and seeing the police party some persons fled away from the said house. Then we entered inside the house and found that, the above noted accused person was attempting to mix some white crystal like substance in a big container filled with liquid substance. Seeing us, he hurriedly tried to hide those articles inside the house, but failed. When we reached very near to the container, a smell like ID liquor was coming out. The white crystal was with a tang smell. On being asked, it revealed that the said accused person was selling ID liquor which contained in that container and now was mixing "NISADAL" (that white crystal like substance) to that liquor to increase the power of that liquor. He also revealed that, the "NISADAL" likely to cause disability and even death of person; but in-taking of this mixture increases the inducement more effectively that ordinary ID liquor. His secret business helped him to get more money by selling such type of intoxicated mixture in the shadow of his normal business.

Accordingly, I seized I.D. Liquor approx 12 Liters in a plastic container and "NISADAL" approx 500 grams under proper seizure list duly signed by my accompanying Police Force as well as I got it signed by the arrested person and also duly labeled.

As the accused person under such circumstances committed an offence punishable U/S 46AA of Bengal Excise Act,1909 So I arrested him after disclosing the ground of arrest & after issuing arrested memo.

I, therefore, pray that, a case U/S 46AA Bengal Excise Act may kindly be started against Simanta Dasgupta @ Fucha (30 Yrs) S/O-Bipin Dasgupta of Vill-Sunuri Majhpara, PS-Santuri, Dist-Purulia and also for arranging its investigation.
