In Producing hear with arrested accd person namely Utpal Mondal (48Years) S/O Lt. Kalipada Mondal, Vill- Bhagaband, PS Santuri Dist Purulia along with seized articles.

I beg to report that on 09.02.24 , at 18:05 hrs I SI Subrata Ghosh of Santuri PS received an information from my reliable source that huge number of wine bottles are staged in one Chiken shop which is situated Ladason market Bhagabandh side and the above noted persons are selling several types of liquor in his respective Chiken Shop styled as— Ladason market Bhagabandh side under –Santuri PS accordingly SI Subrata Ghosh informed to O/C Santuri PS in this regard. As per direction of O/C Santuri PS I SI Subrata Ghosh along with force left to Ladason at the above noted said Chiken Shop to workout the information This refers to Santuri PS GDE No-665 Dt 09.02.24 At about -18:35 hrs myself along with force reached the spot and hold raid at the above noted Chiken Shop and found that the some persons were assembled and consuming liquor in side and outside of the above noted hotel. On seeing police party the assembled persons manage to flee away from the spot. On search I found that the said person has selling the country spirit (DIL SE) company liquor in his respective shop. On demand he failed to produce any valid papers/ documents in support of selling country spirit in his respective Chiken Shop . Then I seized the 1) total 17 sealed bottles of Country sprit (Dil Se) containing 600 ML in each , from the possession of above noted arrested accd person and duly signed by witnesses as well as the accd person and also prepared label.. And arrested accd person namely 1) Utpal Mondal (48Years) S/O Lt. Kalipada Mondal, Vill- Bhagaband PS Santuri Dist Purulia and brought with PS with seized articles.

Therefore I pray before you that kindly arrange to stated specific case under proper section of law -against arrested accd person Utpal Mondal (48Years) S/O Lt. kalipada Mondal, Vill- Bhagaband PS Santuri Dist Purulia and arrange for its investigation.
