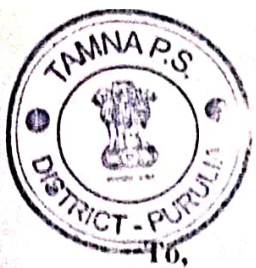

Respected Sir,

I, Parimal Tewary, S/o- Lt. Birendra Nath Tewary of Vill + PO- Maliara, PS- Barjora, Dist- Bankura, ASI of Police of Tamna PS, Dist- Purulia along with force returned to PS and producing herewith the arrested accused driver namely Nimai Bouri (38 Yrs), S/o- Arjun Bouri and other one arrested accused person namely Pintu Kuiry (28 yrs) S/O- Haradhan Kuiry both of Vill- Balarampur, PO- Dabar-Balarampur, PS- Purulia (M), Dist- Purulia along with seized articles i.e. one blue colour Sonalika DI 35 Tractor having Registration No. WB55B-1003 attached with trolley loaded with sand approx. 100 cft

The fact of the case in brief is that today i.e on 22.02.2024, myself along with force i) C/629 Kalyan Soren and ii) C/1084 Pradyut Kr. Ghosh were performing PS area evening & night mobile duty vide Tamna Ps CC No. 657, Dtd- 21.02.24 and Tamna PS GDE No- 874 date- 21.02.2024. During my mobile duty at about 00:35 hrs received credible source information that one Bule colour Tractor is carrying sand illegally from Kansai river near Dumursole bridge towards Dumursole village. Accordingly, myself along with force left to work out the said source information. Then, we intercepted the aforesaid tractor near at Dumursole village under Tamna PS, Dist- Purulia at about 01:15 hrs and found that the above noted tractor was tagged with a trolley loaded with sand (approx. 100 cft.). But seeing the Police party, driver of the tractor & other one fled away leaving the said tractor attached with trolley loaded with sand at Dumursole village. On hot chased I apprehended the driver of the Tractor & one another with the help of my force. I asked the Driver of the said Tractor to produce the valid documents regarding carrying the sand which is loaded on the above noted trolley of the said Tractor. But he failed to produce any valid document in respect of the loaded sand into the trolley of said Tractor. So, I arrested the driver of the Tractor namely Nimai Bouri (38 Yrs), S/o- Arjun Bouri and other one namely Pintu Kuiry (28 yrs) S/O- Haradhan Kuiry both of Vill- Balarampur, PO- Dabar-Balarampur, PS- Purulia (M), Dist- Purulia after observing all legal formalities regarding arrest and also issued one copy memo of arrest to them and told them about ground of arrest and also informed their relatives regarding the ground of arrest. Later on, I seized the above noted Tractor having Reg. No- WB55B-1003 attached with trolley loaded with sand approx. 100 cft. in presence of witnesses after preparing seizure list. So, there is every ground to reason to belief that the owner and driver of above noted tractor dealing in sand business in clandestine manner.

Under the above facts and circumstances kindly take lawful action against the owner and above noted arrested accused persons namely (i) Nimai Bouri (38 Yrs), S/o- Arjun Bouri and (ii) Pintu Kuiry (28 yrs) S/O- Haradhan Kuiry both of Vill- Balarampur, PO- Dabar-Balarampur, PS- Purulia (M), Dist- Purulia of the seized tractor having Registration No- WB55B-1003, attached with Trolley loaded with sand approx. 100 cft.
