In producing here with one arrested accused namely Mithun Ram (22 Yrs) S/O Lt. Ram Avtar Ram of near North Booking Counter, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 10 bottles (in sealed condition) DIL Khush country spirit, 600-ml each bottle, Rs-55 of each bottle.

I ASI Rajkumar Nandy of Adra PS do here by lodged a complaint against accused namely Mithun Ram (22 Yrs) S/O Lt. Ram Avtar Ram of near North Booking Counter, PS-Adra, Dist-Purulia to the effect that on 16/03/24 during my special mobile duty vide Adra PS CC No-652/24 dtd.16.03.2024 at about 18:35 hrs I received a telephonic information from a reliable source that one Mithun Ram has been stock of country spirit illegally of his Jhupri near North Booking Counter. After getting such information I informed to my I/C and as per his direction I along with my accompanied force C/257 Malay Mandal and C/1366 Chandan Chakraborty reached near North Booking Counter Adra at about 19:05 hrs and hold raid in the Jhupri of said Mithun Ram and found that the said person selling liquor at his Jhupri and after seeing the Police party some person fled away and said Mithun Ram has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Mithun Ram selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 19.05 hrs to 19.25 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Mithun Ram (22 Yrs) S/O Lt. Ram Avtar Ram of near North Booking Counter, PS-Adra, Dist-Purulia under proper section of law.
