We, **SantiGopalGorai** and **RekhaGorai**, both residing at Jara, Adra, P.O. & P.S. Adra, District- Purulia, West Bengal-723121 would like to lodge a complaint regarding the abduction of our daughter **HristiGorai**, aged about 20 years (7029816710) by AmritMaitty.

On 13-03-2024, at 10 am, our daughter left home to meet a friend in Adra. However, she did not return home as expected. Upon inquiries with her friends and acquaintances, we discovered that AmritMaitty, son of AshitMaitty residing at Amotha Durgapur, Kathi (Phone No. 9933352164), had been pursuing her for a significant period.

AmritMaitty's persistent pursuit of our daughter had caused us concern in the past. We believe that he used deceitful means and manipulation to influence our daughter, ultimately leading to her abduction. We fear for our daughter's safety and well-being under his influence.

Given the circumstances, we urgently request the police to take immediate and effective action to locate, rescue, and ensure the safe return of our daughter, HristiGorai. We are willing to cooperate fully with the authorities and provide any further information or assistance necessary to expedite the resolution of this matter.

We trust in the capabilities of the police department to handle this case with the utmost seriousness and urgency it deserves. We eagerly await your prompt intervention and positive outcome in ensuring the safe return of our beloved daughter.
