Dear Sir,

I, Rajesh Kumar, S/O-Lt.Gulo Ram, Age-35years , Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Sahajahan Ansari (User) S/O- Lt. Md Ali Hosen Ansari of Village -Herodih, PS-Arsha,Dist-Purulia has committed theft of electricity U/S 138(1)(b) of electricity act 2003 subsequently amendment act 2007.

On 06.03.2024 at about 11.30 o'clock I, along with Alimuddin Ansary,S/O-Lt. Miyazan Ansary, Age-42 years, Sr. TSH, Arsha CCC, and Chandan Mahato S/O- Lt. Phanibhushan Mahato , Age- 36 years, TSH, Arsha CCC went to routine inspection in Herodih Village and entered the premises of Sahajahan Ansari (User) S/O- Lt. Md Ali Hosen Ansari of Village -Herodih, PS-Arsha, Dist-Purulia consumer bearing Id-242049013 and found that Sahajahan Ansari (User) S/O- Lt. Md Ali Hosen Ansari was unauthorisedly reconnected the electric line from nearby LTOH line of WBSEDCL. This electric line was previously disconnected on 07.12.2023 due to bypassing of meter and an FIR was lodged vide FIR NO-159/23, dated-07.12.2023 at Arsha PS. This is his second offence for theft of electricity. The electric line of Sahajahan Ansari (User) S/O- Lt. Md Ali Hosen Ansari with Meter No. DDG256657 again disconnected on the spot from nearby LTOH Line of WBSEDCL. Inspection Report has been prepared on the spot. We also seized the energy meter and a portion of service cable from his premises. The inspection team left the premises of the accused person at about 11.45 o'clock.

Sahajahan Ansari (User) S/O- Lt. Md Ali Hosen Ansari of Village -Herodih, PS-Arsha, Dist-Purulia has committed an offence U/S 138 (1)(b) electricity act 2003 (Amendment Act 2007), so you are requested to take cognizance of this complaint and treat it as FIR.
