Sub: To lodge FIR against owner and driver of one Red colour Mahindra B275 DI tractor having Reg. No. WB55B/1864, Chassis No. MBNABAEXPJKC04674, Engine No. NKB2EMJ0209 along with trolley loaded with sand (approx 100 CFT).

Sir,

In producing herewith, 01(one) Red colour Mahindra B275 DI tractor having Reg. No. WB55B/1864, Chassis No. MBNABAEXPJKC04674, Engine No. NKB2EMJ0209 along with trolley loaded with sand (approx 100 CFT). To the effect that during my Evening mobile duty vide GDE No. 471 Dtd. 11.03.2024, acting on source information & as per direction of O/C, Arsha P.S, I SI Sanjay Kr. Das of Arsha PS along with (i) C/-1193 Manaranjan Bhuin of Arsha PS and (ii) C/280 Rana Sahana of SAP 7th BN camp at Arsha P.S, Dist-Purulia reached at Kansai River Ghat near Asharamdih village, under Arsha PS at 15.35 hrs, we conducted raid on the Bank of Kansai River under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Kansai River Ghat near Asharamdih village on the Bank of Kansai River. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Kansai River Ghat near Asharamdih village, fled away. We rushed to the tractor and detained the said tractor. Then we searched the said tractor and found that the tractor was loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying and were doing illegal activities vide Memo No. VI/430/(Part-VIII)/2187/1(51)/M/17 Dtd. 03.07.2023 & Memo No. VI/430/(Part-VIII)/ 3326(51)/M/17 of the DM, Purulia.

Hence, I do hereby lodge this complaint against the owner and driver of above noted one Red colour Mahindra B275 DI tractor having Reg. No. WB55B/1864, Chassis No. MBNABAEXPJKC04674, Engine No. NKB2EMJ0209 along with trolley loaded with sand (approx 100 CFT) for investigation.
