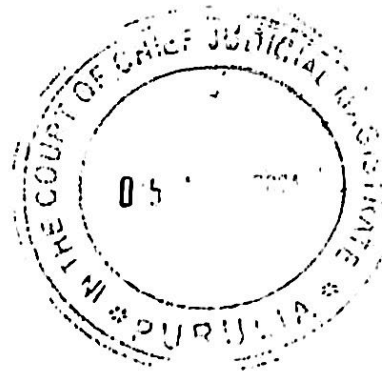
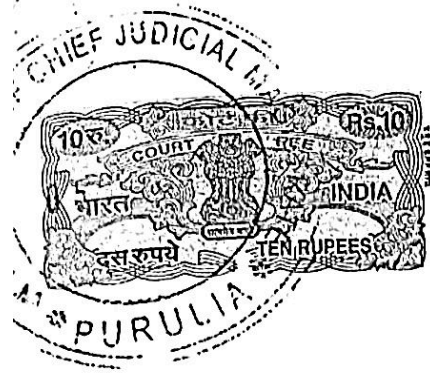

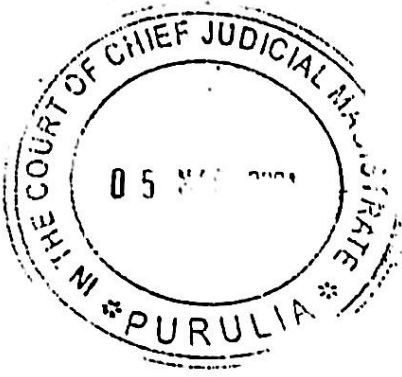

Malati Mandal @ Tusu Mandal Wife of Ganesh Mandal, though Malati Mandal is alive but Tusu Mandal has no name as Malati Mandal but the said Tusu Mandal in collusion with other Accused by cheated the Complainant prepared a Registered Deed of Gift in favour of Sarala Mandal being No. 3753/2022 dated 29.12.2022 and also mutated in the name of Accused No.4, and the Complainant founds first time on 07.12:2023 when the BL&LRO gave a certified copy to the Complainant in the names of Accused No.4 and thereafter Complainant lodged complaint before O/C Arsha P.S. by Regd. Post on 27.02.2024 and also lodged complaint before S.P. Purulia on 23.02.2024 but till now Concerned Authority did not take any step. Be it mentioned here, that in the month of December, 2023 Complainant also lodged complaint before O/C Arsha P.S but he did not give any receipt to the Complainant so the Complainant file this petition against the Accused Persons for relief
