Sir,

In producing here with one arrested accused Prayag Roy (40 yrs) S/O Lt. Pranabesh Roy of vil. Gouradag, P.S. Arsha Dist-Purulia, along with following seized articles.

- (1) One white colour plastic container with approx. 16 ltrs of 1D liquor.  
(Approx. 500 ml taken out from of the above container as sample packed with sealing wax)

I, ASI Khurud Baran Sardar of Arsha P.S do hereto lodge a written complaint against the above noted accused person to the effect that today i.e 16.03.2024 at about 16.45 hrs during my off-duty at PS area, receive source information over telephone that the above noted accused has been selling 1D Liquor in his house at Gouradag village. On receiving the reliable source information I communicated with OIC Arsha PS over telephone and as per his instruction I along with 1) C-333 Sitaram Mukherjee and 2) C-605 Bidyut Ghosh both of SAP 7th BN camp at Arsha PS, rushed in the house of Prayag Roy (40 yrs) S/O Lt. Pranabesh Roy of vil. Gouradag, P.S. Arsha Dist-Purulia to work out the information vide Arsha PS G.O.E No. A/27 Dtd. 16.03.2024. Reaching at Gouradag village at about 16.45 hrs we fixed-up in the house of above noted acc'd person Prayag Roy (40 yrs) S/O Lt. Pranabesh Roy of vil. Gouradag, P.S. Arsha Dist-Purulia and found that selling of 1D Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehend the above noted accused person. On demand of showing papers he failed to produce any valid documents to support of selling 1D liquor. So I seized all the impounding articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and later duly signed by the accused persons and witnesses among which approx. 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling 1D liquor illegally.

I therefore pray that a specific case may kindly be started against the accused Prayag Roy (40 yrs) S/O Lt. Pranabesh Roy of vil. Gouradag, P.S. Arsha Dist-Purulia under proper section of law.
