In producing here with one arrested accused person Jagadish Kumar (42yrs) S/O- Umacharan Kumar of vill- Palpal, P.O - Arsha, P.S. Arsha, Dist Purulia along with following seized article.

1) 10 bottle County Spirit marked as Dil Khush, 600 ML each bottle (Rs-55/- each bottle.  
(One bottle taken out of the above as sample packed labeled and sealed with sealing wax).

I, ASI Khirod Baran Sardar of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 24.03.2024 at about 18.15 hrs. during my evening mobile duty at Jari Morh under Arsha PS, receive source information over telephone that the above noted accused has been selling Country spirit at Palpal village. On receiving the source information I communicated with O.C Arsha PS over telephone and as per his direction I along with C/- 1437 Soumen Kr. Pati of Arsha P.S and C/- 280 Rana Sahana of SAP 7th BN camp at Arsha PS rushed at Palpal village to work out the information vide Arsha PS GDF No. 10-H & CC No. 936 dtd. 24.03.2024. Reaching at Palpal village at about 18.35 hrs we fixed-up in the grocery shop of Jagadish Kumar (42yrs) S/O- Umacharan Kumar of vill- Palpal, P.O -Arsha, P.S.-Arsha, Dist-Purulia and found that 10 bottles County Sprit marked as Dil Khush, 600 ML each bottle & Rs-55/- each bottle on seeing police, customers fled away. But we were able to apprehend the above noted accused person namely Jagadish Kumar (42yrs) S/O- Umacharan Kumar of vill- Palpal, P.O -Arsha, P.S.-Arsha, Dist- Purulia, who was selling Country Spirit which he use to sell clandestinely to make his profit. On demand he failed to produce any valid documents in support of selling Country Spirit. Accordingly, I seized all those articles after preparing a proper seizure list and put label on all the seized articles from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses and one bottle of that seizure was taken as sample which was also duly labeled. It took time from 18.55 hrs. to 19.05 hrs. During interrogation he confessed his guilt. Therefore, I arrested him at 19.25 hrs after observing all the formalities issuing memo of arrest.

Under the above circumstances I, therefore, pray that a specific case u/s 46 (A)(c) of The Bengal Excise Act may kindly be registered against said Jagadish Kumar (42yrs) S/O- Umacharan Kumar of vill- Palpal, P.O -Arsha, P.S.-Arsha, Dist-Purulia and also for arranging its investigation.
