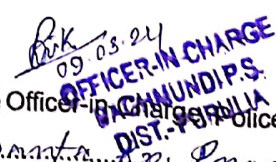

Sir,

In producing herewith the Two (02) arrested tractor drivers namely (i) Bhutnath Mahato (40 yrs), S/O- Madhusudan Mahato of Vill- Letemda, PO- Kukru, PS- Tiruldih, Dist- Saraikela Kharswan, Jharkhand (Driver of DI 35 SONALIKA INTERNATIONAL) (ii) Brishasen Mahato (24 Yrs), S/O- Kiriti Mahato of Vill- Daruda, PO- Kukru, PS- Tiruldih, Dist- Saraikela Kharswan, Jharkhand (Driver of SWARAJ 735 FEE) and two (02) seized Blue Colour tractors (i) SWARAJ 735 FEE tractor having Eng No- CJ.1354/SFL28186 & Chasis No- MBNAK48ACRTA23500 and (ii) DI 35 SONALIKA INTERNATIONAL tractor having Eng No- 3100FLU34G1327621F18 & Chasis No- EZJSK1340051SM fitted with trolley loaded approx 100 cft sand in each trolley under proper seizure list. I beg to submit that today (09.03.2024) I along with (1) C/1539 Buddhadeb Chaterjee (2) C/2945 Asim Kr. Singha Mahapatra both of Baghmundi P.S were performing evening mobile duty vide Baghmundi PS CC No-605/2024, Date-09.03.2024. During evening mobile duty at about 22:05 hrs I received a source information that 02 suspicious tractors loaded with sand were coming from Sirum,-Niltar Road near Rerengtar village. I informed this matter to OC Baghmundi PS and after getting necessary permission I along with force left for the said place.

During my evening mobile duty at about 22:15 hrs I along with force reached at Rerengtar village and found that 02 (Two) Blue Colour tractors (i) SWARAJ 735 FEE tractor having Eng No- CJ.1354/SFL28186 & Chasis No- MBNAK48ACRTA23500 & (ii) DI 35 SONALIKA INTERNATIONAL tractor having Eng No- 3100FLU34G1327621F18 & Chasis No- EZJSK1340051SM along with sand loaded trolley were coming from Sirum,-Niltar Road near Rerengtar village. On seeing the Police party near Rerengtar village, the drivers of those tractors were trying to flee away. But after a hot chase, we could able to detain them. I asked the drivers Bhutnath Mahato and Brishasen Mahato to produce valid documents in respect of said sand but they failed to produce any documents regarding lifting & transportation of sand. I interrogated them thoroughly. During interrogation, they admitted that they are dealing with illegal sand lifting from Subarna-Rekha river bed. The owners of the said tractors were also involved in this illegal lifting and transportation. Hence, I seized the 02 (two) Blue Colour tractors (i) SWARAJ 735 FEE tractor having Eng No- CJ.1354/SFL28186 & Chasis No- MBNAK48ACRTA23500 & (ii) DI 35 SONALIKA INTERNATIONAL tractor having Eng No- 3100FLU34G1327621F18 & Chasis No- EZJSK1340051SM fitted with trolley loaded approx 100 cft sand in each trolley and 01 KG (Approx) sand from each trolley as sample in between 22:35 hrs to 23:05 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested the said drivers namely (i) Bhutnath Mahato (40 yrs), S/O- Madhusudan Mahato of Vill- Letemda, PO- Kukru, PS- Tiruldih, Dist- Saraikela Kharswan, Jharkhand, (ii) Brishasen Mahato (24 Yrs), S/O- Kiriti Mahato of Vill- Daruda, PO- Kukru, PS- Tiruldih, Dist- Saraikela Kharswan, Jharkhand at 23:15 hrs. I brought the said sand loaded tractors to Baghmundi P.S compound as such there is every reason to believe that the drivers and owners of the vehicles with ill motive dealing with sand illegally without any valid document.

Therefore, I pray before you that a case may kindly be started and arrange for its investigation.
