To, The Officer In Charge Baghmundi Police Station Purulia

Sub: Lodging of F.I.R of theft of Electricity against Bimala Bhagat, W/o Lt. Bhaktipada Bhagat at his Domestic premises at Vill.-Suisa, P.S.-Bagmundih and thereby committed an offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

Dear Sir.

This is to inform you that, I Sri Sisir Kumar Das (35), S/O – Banamali Das, D.E. & Station Manager of Bagmundih CCC of WBSEDCL received an information to the effect that Bimala Bhagat, W/o Lt. Bhaktipada Bhagat residing at Vill.- Suisa was committing theft of Electricity at her Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 12.03.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit had been to the house of Bimala Bhagat at the above mentioned address. She was present at her house. We contacted her and disclosed our identity to her. On being asked she allowed us to inspect the Energy meter of WBSEDCL installed at her domestic premises against the name of the consumer namely Bimala Bhagat.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a two storied building and the meter is installed at the entrance of that premises. Immediately, a notice was prepared duly signed by her served upon the consumer and held inspection.

During inspection, it was detected that, Bimala Bhagat had tampered the energy meter installed at Domestic premises bearing meter No: BR505246 in the name of Bimala Bhagat at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter to commit theft of Electricity. Inspection also revealed that Bimala Bhagat was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit disconnected the above mentioned service connection and removed the Energy meter bearing SI no: BR505246 after securing the installation place of the said meter from any imminent danger in future. She was shown the tampered meter but being asked she could not render any satisfactory explanation. She was informed about the offence committed by her and its penal provision.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared inspection report in her presence and witnesses at the spot and load assessed as 3.1KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the energy meter of Bimala Bhagat, it is well established that Bimala Bhagat was consuming Electricity illegally in her Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said premises and meter in presence of the consumer and witnesses at the spot.

The inspection was held between 03:50PM to 04:15PM today after observing all legal formalities.

It is well evident that accused Bimala Bhagat, W/o Lt. Bhaktipada Bhagat of Vill.- Suisa has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
