I, Kunti Kumari, W/o Ashok Chandra Majhi, D/o  
Late Rampada Kumhar, resident of Brahmin Tola, Adityapur,  
P.O and P.S. Adityapur, Dist. Sereikella Kharsawan, Jharkhand,  
831013, do hereby begs to submit as follows :-

That Ashok Chandra Majhi, S/o Late ~~Wadka~~ Duluram Majhi,  
resident of Sarebandi, P.O. Madla, P.S. Bagmudi, District of  
Purulia, West Bengal, is my husband and our marriage was  
solemnize on 09/09/2017 at Deori Mandir, situated at Tamar,  
within District Ranchi, Jharkhand and the said marriage was  
in a romantic situation and I am physically handicapped.

That after our marriage due to my physically handicapped  
the inmatires of my husband and the member of my matrimonial  
house are not accepted in matrimonial house for a longer time  
and during this time my said husband along with his family  
members were started mentally and physically tortured as a  
result, I made an FIR vide Jhargram P.S. Case No. 38/2020  
corresponding to G.R. Case No. 252 /20 U/s 498A/406/417/506/  
34 I.P.C. as my said husband is working as constable posted  
at Banspahr O.P. in District Jhargram. Later on my said  
husband come to my parental residence at Adityapur in the  
District Sereikella Kharsawan, and made compromise as per  
his assurance, I talked to my advocate in Jhargram to  
compromise that case.

That after a few days again at my residence my husband again started tortured towards me then I again lodged an FIR against my husband vide Ajityapur P.S. Case No.150/21, corresponding to G.R. Case No.334/23, U/s 498A/323/406/420 I.P.C. which is still pending before the Honble Chief Judicial Magistrate, at Seraikella, Jharkhand and I have filed a maintenance case also against my said husband U/s 125 Cr.P.C which is also pending before Honble Principal Judge, Family Court, at Serakella which is also still pending on the other hand my husband filed a case against me U/s 34 of Special Relief Act - 1963, ~~U/s~~ which is also pending in the Court of Seraikella Kharsawan, Jharkhand.

That on 11.03.2024, I got a telephonic message that my said husband got married with a lady who is residing at Kalimati, Vill- Bidni, under P.S. Bagmundi, P.O. Kunturi, Block -Serangdi, Purlia, I immediately rushed to my matrimonial house at Saragdi to meet my husband but my said husband and matrimonial misbehaved with me.

That I beg to state that my husband broken this law and re-married with another lady whenever we have not declared Divorce, so as per law out country my husband committed breach of trust and without Divorce me, remarried again with other lady


I, therefore request your goodself please take the appropriate action to order, my said husband Ashok Chandra Majhi,
