Sir,

In producing herewith the One (01) arrested tractor driver namely (i) Mongal Singh Mura s/o-Lt Kartick Singh Mura of Kantadi Ps- Bagmundi Purulia (Driver of Tractor Mahindra Model No-B275 DI TU MKM DLX, and three (03) seized tractors (i) Mahindra Model No-B275 DI TU MKM DLX Chasis No-MBNABAEXKPNE01864, Engine No-NPE2EAE0154) (ii) Mahindra Model No-B275 DI TU MKM DLX ChasisNo-MBNABAEXKPRF13524, EngineNo-RPF2EAN3247, III) DI35 SONALIKA INTERNATIONAL tractor having Model No-3531A4577LDAJUD, Chasis No-KZJSK1375087SM Eng No- 3100FLU34J1361396f18 fitted with trolley loaded approx 100 cft sand in each trolley under proper seizure list. I beg to submit that today (28.03.2024) I along with C/913 Aditya Mondal and C/1411, Sunil Das both of Bagmundi P.S were performing night mobile duty vide Bagmundi PS CC No-802/2024, Date-27.03.2024. During night mobile duty at about 07.25 hrs I received information from O/C Bagmundi PS that 03 suspicious tractors loaded with sand were coming from Chora Jharkhand side to Charida through Sindri. Accordingly I along with force left for the said place.

Same day on-28.03.24 at about 08.05 hrs I along with force reached at Sindri More under Bagmundi Ps. After few times I wait thereafter found that 03 (Three) Tractor fitted with trolley loaded sand in each trolley were coming from Chora Jharkhand side to Charida through Sindri. On seeing the Police party near Sindri More, the drivers of those tractors were trying to flee away and conceal them with vehicle. But after a hot chase, we could able to detain one out of three and other two persons fled away. I asked the driver Mongal Singh Mura to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, He admitted that they are dealing with illegal sand lifting from Subarna-Rekha river bed. The other two drivers of the said tractors and Owners of the said tractors and more than 4/5 others were also involved in this illegal lifting and transportation. Hence, I seized the 03 (three) i) Mahindra Model No-B275 DI TU MKM DLX Chasis No-MBNABAEXKPNE01864, Engine No-NPE2EAE0154) (ii) Mahindra Model No-B275 DI TU MKM DLX ChasisNo-MBNABAEXKPRF13524, EngineNo-RPF2EAN3247, III) DI35 SONALIKA INTERNATIONAL tractor having Model No-3531A4577LDAJUD, Chasis No-KZJSK1375087SM Eng No- 3100FLU34J1361396f18 fitted with trolley loaded approx 100 cft sand in each trolley and 01 KG (Approx) sand from each trolley as sample in between 10:25 hrs to 11.15 hrs under proper seizure list in presence of available witnesses duly signed by him and I arrested the said driver namely (i) Mongal Singh Mura s/o-Lt Kartick Singh Mura of Kantadi Ps- Bagmundi Purulia (Driver of Tractor Mahindra Model No-B275 DI TU MKM DLX, at 11.25 hrs. I brought the said sand loaded tractors to Bagmundi P.S compound as such there is every reason to believe that the Drivers/Owners of the vehicles and others persons with ill motive dealing with sand illegally without any valid document.

Therefore, I pray before you that a case may kindly be started and arrange for its investigation.
