Respected Sir,

In producing herewith one arrested accused person namely Santosh Kumar @ Bhocha (59yrs), S/O- Lt Mutru Kumar of Vill- Baghdih, PS-Balarampur, Dist- Purulia with Memo of Arrest and seized articles viz. one Iron Made improvised single barrel fire arms having length 9 inch (approx) with iron butt, body, barrel, trigger, hammer, firing pin etc with 02 (two) rounds .303 cartridges under proper seizure list. I, S.I Shyamalendu Chowdhury of Balarampur PS, Dist- Purulia beg to inform you that today (On 04/03/2024) at about 21:15 hrs in course of my Naka Checking duty (Vide Balarampur PS GDE No-175, CC No-505 date-04/03/2024) along with C/468 Raju Roy, C/1028 Abhijit Pal, C/1002 Somlal Murmu and C/2009 Buddhadeb Dey at Dantia Naka Point, under Balarampur PS, found one person aged about 60 years is coming from Jharkhand side by feet through Jamshedpur- Purulia road. After seeing the police personnel at Dantia Naka Point he suddenly turned around and tried to run away from the spot. After observing his suspicious movement myself along with force started chasing him, after a short chase we finally nabbed him and on searching one Iron made improvised single barrel fire arms having length 9 inch (approx) loaded with 01 (one) round .303 lives cartridges was recovered from his right side waist being kept supported with his paint and another one round .303 cartridges was recovered from his left side pant pocket. All the items under proper seizure list were recovered from his exclusive possession and unloaded the same safely. On being asked he failed to produce any documents in support of possessing or keeping the said fire arms. He also disclosed his identity as Santosh Kumar @ Bhocha (59yrs), S/O- Lt Mutru Kumar of Vill- Baghdih, PS-Balarampur, Dist- Purulia. Accordingly I seized the above noted articles from his exclusive possession in-between 21.35 hrs & 22.05 hrs under proper seizure list and being labeled properly. During seizure & label I searched for the local disinterested persons to put sign on the Seizure List as well as Label, but no public witness could be made available. After seizure I arrested him at 22.10 hrs after observing all the legal formalities regarding arrest as his offence comes under the purview of Indian Arms Act.

Hence, I pray that a specific case may kindly be started against him under proper section of law and arrange for its investigation.
