I beg to submit that on 01/03/2024 at about 19:25 hrs. I received a credible source information while I was engaged in Evening Mobile duty vide Bandwan PS C.C No.-725/24 Date- 01.03.2024 that one person namely Rupchand Majhi, S/O- Lt. Motilal Majhi of Village- Liki, P.O- Jitan, PS- Bandwan, Dist- Purulia is selling Illicit Distill liquor (CHOLAI MOD) without any valid license in front of his house at Liki village under Bandwan PS. Accordingly, I informed the said information to O/C, Bandwan P.S and as per his direction, myself along with C/358 Ganesh Ch. Roy and C/788 Rabindranath Baidya both are of Bandwan P.S, Dist-Purulia left for Liki village to work out the said source information and found that the said person is selling I.D liquor (CHOLAI MOD) to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person namely Rupchand Majhi, S/O- Lt.
