
In producing herewith one arrested accused person namely Rupchand Majhi (Male /59 Yrs. Approx.), S/O- Lt. Motilal Majhi of Village- Liki, P.O- Jitan, PS- Bandwan, Dist- Purulia with the seized articles i.e. 1) approx 09 (Nine) litres illicit distil liquor in 01 (One) jericin marked as Exhibit "A" from which 01 (One) Litre has been taken out in one separate bottle from mother quantity as sample marked as Exhibit "B" and 2) 10 (Ten) Plastic glasses marked as Exhibit "C". I beg to submit that on 01/03/2024 at about 19:25 hrs. I received a credible source information while I was engaged in Evening Mobile duty vide Bandwan PS C.C No.-725/24 Date- 01.03.2024 that one person namely Rupchand Majhi, S/O- Lt. Motilal Majhi of Village- Liki, P.O- Jitan, PS- Bandwan, Dist- Purulia is selling Illicit Distill liquor (CHOLAI MOD) without any valid license in front of his house at Liki village under Bandwan PS. Accordingly, I informed the said information to O/C, Bandwan P.S and as per his direction, myself along with C/358 Ganesh Ch. Roy and C/788 Rabindranath Baidya both are of Bandwan P.S, Dist-Purulia left for Liki village to work out the said source information and found that the said person is selling I.D liquor (CHOLAI MOD) to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person namely Rupchand Majhi, S/O- Lt. Motilal Majhi of Village- Liki, P.O- Jitan, PS- Bandwan, Dist- Purulia. On being asked, he failed to produce any valid documents/ License in respect of selling of Illicit Distil liquor. Accordingly, I seized and labelled all the Illicit Distilled liquor (details in attached seizure list) i.e 1) approx 09 (Nine) litres illicit distil liquor in 01 (One) jericin marked as Exhibit "A" from which 01 (One) Litre has been taken out in one separate bottle from mother quantity as sample marked as Exhibit "B" and 2) 10 (Ten) Plastic glasses marked as Exhibit "C" as produced by the said accused Rupchand Majhi from 19:45 hrs to 20.05 hrs and prepared proper seizure list duly signed by the witnesses. Then, I arrested him at 20:25 hrs maintaining all legal procedures regarding arrest as per Cr.P.C, NHRC guide lines and as laid down by Hon'ble Supreme Court as he committed offence U/S- 46A (c) Bengal Excise Act. 1909. I would like to note down here that after local enquiry the arrest was made because a cognizable offence was being committed in presence of a Police Officer.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) Bengal Excise Act. 1909 against the arrested accused person namely Rupchand Majhi (Male /59 Yrs. Approx.), S/O- Lt. Motilal Majhi of Village- Liki, P.O- Jitan, PS- Bandwan, Dist- Purulia and arrange for it's investigation.
