In producing herewith one arrested accused person namely Chandra Kishore Gorain (Male /50 Yrs. Approx.), S/O- Late Sucharu Gorain of Village- Roladih, P.O- Gangamanna, PS- Bandwan, Dist- Purulia with the seized articles i.e. 1) approx 13 (Thirteen) litres illicit distil liquor (CHOLAI MOD) in 02 (Two) Jericans (Approx 09 Ltrs. in one Jarican marked as Exhibit "A") & (Approx 04 Ltrs. in one another Jarican marked as Exhibit "B") from which 01 (One) Litre in each said Jaricans has been taken out in 02 (Two) separate bottle from mother quantity as sample marked as Exhibit "C" & "D" and 2) 12 (Twelve) Plastic glasses marked as Exhibit "E". I beg to submit that on 20/03/2024 at about 19:15 hrs. I received a credible source information while I was engaged in Evening Mobile duty vide Bandwan PS C.C No.-979/24 Date- 20.03.2024 that one person namely Chandra Kishore Gorain S/O- Late Sucharu Gorain of Village- Roladih, P.O- Gangamanna, PS- Bandwan, Dist- Purulia is selling Illicit Distil liquor (CHOLAI MOD) without any valid license in front of his Grocery Shop (Goldari Dokan) near Hari Mandir at Roladih village under Bandwan PS. Accordingly, I informed the said information to O/C, Bandwan P.S and as per his direction, myself along with C/398 Bibhisan Sing and C/1302 Radha Gobinda Dhibar both are of Bandwan P.S, Dist-Purulia left for Roladih village to work out the said source information and found that the said person is selling I.D liquor (CHOLAI MOD) to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person namely Chandra Kishore Gorain (Male /50 Yrs. Approx.), S/O-Late Sucharu Gorain of Village- Roladih, P.O- Gangamanna, PS- Bandwan, Dist- Purulia. On being asked, he failed to produce any valid documents/ License in respect of selling of said Illicit Distil liquor (CHOLAI MOD). Accordingly, I seized and labelled all the Illicit Distilled liquor (details in attached seizure list) i.e 1) approx 13 (Thirteen) litres illicit distil liquor (CHOLAI MOD) in 02 (Two) Jericans (Approx 09 Ltrs. in one Jarican marked as Exhibit "A") & (Approx 04 Ltrs. in one another Jarican marked as Exhibit "B") from which 01 (One) Litre in each said Jaricans has been taken out in 02 (Two) separate bottle from mother quantity as sample marked as Exhibit "C" & "D" and 2) 12 (Twelve) Plastic glasses marked as Exhibit "E" as produced by the said accused Chandra Kishore Gorain from 19:50 hrs to 20.10 hrs and prepared proper seizure list duly signed by the seizure witnesses. Then, I arrested him at 20:25 hrs after maintaining all legal procedures regarding arrest as per Cr.P.C, NHRC guide lines and as laid down by Hon'ble Supreme Court as he committed offence U/S- 46A (c) Bengal Excise Act. 1909. I would like to note down here that after local enquiry the arrest was made because a cognizable offence was being committed in presence of a Police Officer.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) Bengal Excise Act. 1909 against the arrested accused person namely Chandra Kishore Gorain (Male /50 Yrs. Approx.), S/O- Late Sucharu Gorain of Village- Roladih, P.O- Gangamanna, PS- Bandwan, Dist-Purulia and arrange for it's investigation.
