Complain against Shibu Gorain (Male /29 Yrs. Approx.), S/O- Late Jagannath Gorain of Vill + P.O-Gangamanna, PS- Bandwan, Dist- Purulia to start a Specific Case U/S 46A(c) Bengal Excise Act. Sub: 1909.

In producing herewith one arrested accused person namely Shibu Gorain (Male /29 Yrs. Respected Sir, Approx.), S/O- Late Jagannath Gorain of Vill + P.O- Gangamanna, PS- Bandwan, Dist- Purulia with the seized articles i.e. 1) Approx. 06 (Six) litres illicit distil liquor (CHOLAI MOD) in 01 (One) Jerican marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate bottle from mother quantity as sample marked as Exhibit "B" 2) 07 (Seven) sealed bottle Kingfisher (Strong) beer of net quantity 650 ml each, Total Volume - 4.550 Ltrs. @ Rs, 135/- each bottle, Total Value - Rs. 945/- marked as Exhibit "C" from which 01 (One) bottle has been taken out from mother quantity as sample marked as Exhibit "D" 3) 10 (Ten) Plastic glasses marked as Exhibit "E". I beg to submit that on 23/03/2024 at about 19:05 hrs. I received a credible source information while I was engaged in Evening Mobile duty vide Bandwan PS C.C No.- 1018/24 Date- 23.03.2024 that one person namely Shibu Gorain, S/O- Late Jagannath Gorain of Vill + P.O- Gangamanna, PS- Bandwan, Dist- Purulia is selling Illicit Distil liquor (CHOLAI MOD) and Foreign liquor without any valid license in front of his Grocery Shop (Goldari Dokan) at Gangamanna village under Bandwan PS. Accordingly, I informed the said information to O/C, Bandwan P.S and as per his direction, myself along with C/2485 Tirthankar Samanta, C/398 Bibhisan Sing and LC - 981 Bharati Murmu all are of Bandwan P.S, Dist-Purulia left for Gangamanna village to work out the said source information and found that the said person is selling I.D liquor (CHOLAI MOD) and Foreign liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person namely Shibu Gorain (Male /29 Yrs. Approx.), S/O- Late Jagannath Gorain of Vill + P.O- Gangamanna, PS- Bandwan, Dist- Purulia. On being asked, he failed to produce any valid documents / License in respect of selling of said Illicit Distil liquor (CHOLAI MOD) and Foreign liquor. Accordingly, I seized and labelled all the Illicit Distilled liquor and Foreign liquor (details in attached seizure list) i.e 1) Approx. 06 (Six) litres illicit distil liquor (CHOLAI MOD) in 01 (One) Jerican marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate bottle from mother quantity as sample marked as Exhibit "B" 2) 07 (Seven) sealed bottle Kingfisher (Strong) beer of net quantity 650 ml each, Total Volume 4.550 Ltrs. @ Rs, 135/- each bottle, Total Value - Rs. 945/- marked as Exhibit "C" from which 01 (One) bottle has been taken out from mother quantity as sample marked as Exhibit "D" 3) 10 (Ten) Plastic glasses marked as Exhibit "E" as produced by the said accused Shibu Gorain from 19:35 hrs to 19.55 hrs. and prepared proper seizure list duly signed by the seizure witnesses. Then, I arrested him at 20:05 hrs. after maintaining all legal procedures regarding arrest as per Cr.P.C, NHRC guide lines and as laid down by Hon'ble Supreme Court as he committed offence U/S- 46A (c) Bengal Excise Act. 1909. I would like to note down here that after local enquiry the arrest was made because a cognizable offence was being committed in presence of a Police Officer.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) Bengal Excise Act. 1909 against the arrested accused person namely Shibu Gorain (Male /29 Yrs. Approx.), S/O- Late Jagannath Gorain of Vill + P.O- Gangamanna, PS- Bandwan, Dist- Purulia and arrange for it's investigation.
