St.-Pur Sub: Prayer for lodging FIR as per law against the Driver & Owner of the stone loaded dumper having registration no- JH 10CD/3168 loaded 28 MT (Ton) approx, stone.

Sir,

In producing here with one arrested accused person namely Chhalku Mahato (35 Yrs) S/o-Ramu Mahato of Vill- Khudilong, PO- Janum, PS- Nimdih, Dist- Saraikella Kharswan (Jharkhand) and brought under seizure one Blue-White colour dumper having Registration No- JH 10CD/3168 loaded 28 MT (Ton) approx. stone, from which 02 Kg (Two) seized as sample.

I beg to state that on 06.03.2024 myself along with ASI Rabindranath Mandal, C/- 347 Manas Pathak and C/- 3218 Sukchand Mandi all are of Barabazar PS were performing evening mobile duty vide Barabazar PS GDE No- 347 Dtd. 06.03.2024 & CC No-950 Dtd. 06.03.2024 with Govt. vehicle. When we are going towards Sindri village on Laka to Sindri pitch road and reached near Bio-degradable waste management plant of Vill-Sindri, under Barabazar PS at about 18.05 hrs found that the said stone loaded dumper standing the beside the pitch road at that place. Seeing the police party, the driver was tried to escape the place with the offending dumper. However, after a hot chase we apprehended the driver along with the offending dumper. On being interrogation the driver of the said offending vehicle disclosed his identity as noted above. After that I asked him to produce any valid documents in r/o excavated stone which is loaded in dumper and whether he has any permission for quarry stone on that land but he failed to produce any valid document for excavation of stone.

I conveyed the same to I.C Barabazar PS. Over mobile phone and Seized the Dumper bearing Registration No- JH 10CD/3168 loaded 28 MT (Ton) approx. stone and also 02 (Two) Kg. taken from which as sample under proper seizure list duly signed by witness. The seizure was done in between 18.15 hrs and 18.40 hrs. After that at 18.45 Hrs I arrested the accused driver as noted above after maintaining all formalities regarding arrest. I also informed him regarding the grounds of arrest and informed his relative.

Held an enquiry about the matter and so far information collected it is crystal clear that the driver and the owner of the Dumper collected the stone by illegal means with intent to make unlawful profit by unlawful collection of stone through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of mine & minerals. As such there is every reason to believe that the driver and owner of the said Dumper with ill motive were transporting the stone illegally without any valid document in support of carrying the stone. They violated the Govt. order of not extracting stone. As such they were doing illegal business activities.

It consumed some time and some delay was occurred to return at PS. After returning at PS, I prepared this letter of complaint and handing over it to I.C BZR PS for starting a case under proper section of law.

Under the above facts and circumstances, I pray before you that kindly take needful action against the arrested **driver** namely Chhalku Mahato (35 Yrs) S/o- Ramu Mahato of Vill-Khudilong, PO- Janum, PS- Nimdih, Dist- Saraikella Kharswan (Jharkhand) & **owner** of the dumper bearing Registration No- JH 10CD/3168, and the person(s) responsible for illegal mining of minerals & also request for arranging its investigation.
