Respected Sir,

With due respect I beg to state that I am the legal married wife of Tausif son of Takir Hossain of Barabazar purulia our marriage was solemnized on 19/05/2023 in presence of Muslim Marriage Registrar and in presence of both parties and respectable persons. As per demand of my husband, parents in law and other my father gifted 60 gr.of golden ornaments 20 Bhoris of silver ornaments, one motor cycle, frize, divan, Almirah, Dinning table, 2 sets 8 chairs, Dressing table, washing machine, Air cooler, Fan alna, various type of utensils including Kansa, steel and other items as per demand. Besides that my father paid a sum of Rs. 1,50,000/- in cash, (one lakh fifty thousand). "fter marriage I went to my Law's house and stayed there peacefully for certain days. During stay my husband, Takir Hossain, Father-in-law, Sufia Begummother-in-law, Soma Parvin d/o Takir Hossain, Sk. Samir son of Sk. Jamil, the Jamai Babu of Takir Hossain, Gulapsa Parvin d/o Takir Hossain, Sk. Faruk son of Sk. Laltu, Jamai of Takir Hossain one Apsara Parvin-Bhagni of my husband daughter of sk. samir tortured me both mentally and physically and they in furtherence of common intention assaulted me, confined me in room without giving any fooding and to create pressure upon me to a sum of Rs. 2,00,000/-(two lakh) for business purpose. I refused to pay the said amount but they -----

I informed the matter to my father who went to Barabazar in the house of my husband and tried to solve the matter but it was in vain. They abused my father with filthy languages and asked my father to pay the said Additional amount otherwise they will not stop the situation. My father stated to my Law's that he is not in a capacity to pay a huge amount. In presence of my father, all the above noted persons threatened me with dire consequences. my father did not lodge any complaint with a hope that they will change but it was in vain.

My husband with collusion of the above named persons after consulting with Doctor arranged to miscarriage my pregnancy when I was running two months. My husband forced me to take medicine.

on 27/10/2023 my husband after consultation with above named persons left me in my father's house with an assurance that after 5/6 days my husband will come but my husband did not visit. So that my parents went to Barabazar in my law's house including myself, but they did not allow us to enter in my room. They further demanded the said additional money otherwise they will not allow me to stay in my law's house. When my parents refused to pay the said amount they threatened us to leave the house. Now I am residing in the care of my father's custody on 03.03.24 my husband came to our house in absence of my father and

and asked me to accept the Talaque and file a suit and refused to live with me as husband and wife and threatened me that he will arrange gundas to murder me. The above named persons are very dengerous and desparate. They have spoiled my life, miscarriage by supplying medicine and also arrange me not to conceive further. When I used to visit Digudih, I narrated the facts to my parents and others. All the gifted articles are now lying in the capacity of my husband, Parent in law and there is every chance of mis appropriation the valuable articles for their personal gain and profit. Due to mental agony, I could not submit the complaint to Polist Station, hence the delay.

Hope that will take tegal steps according to law against the above named persons and save tender aged woman and to save the life etc. according to law as early as possible.
