Sub: Complaint against Meghnath Mahato @ Honda (33 yrs) S/o Lahur Mahato of Vill-Dumurdih (Bhalukuli), PS-Barabazar, Dist-Purulia to start a specific case under proper section of Law.

Sir,

In producing here with one arrested accused person namely Meghnath Mahato @ Honda (33 yrs) S/o Lahur Mahato of Vill-Dumurdih (Bhalukuli), PS-Barabazar, Dist-Purulia along with Memo of arrest, Seizure List, Check List and seized article i.e- 01 (One) white colour Plastic Jarikane containing approx 20 (Twenty) liters of I.D liquors (Cholai) from which 500 ML ID Liquor (Cholai) kept as sample from mother contrabands.

I, SI Nimai Ch. Nemo of Barabazar PS do hereby lodge this complaint against Meghnath Mahato @ Honda (33 yrs) S/o Lahur Mahato of Vill-Dumurdih (Bhalukuli), PS-Barabazar, Dist-Purulia, to the effect that on today i.e. 20.03.2024 during my evening mobile duty vide Barabazar PS GDE No- 1217 Dtd. 20.03.2024 and C.C. No. 1028/24 Dt. 20.03.2024 received a source information that one person unauthorized keeping & selling I.D liquor (Cholai) at Dumurdih Village, under Barabazar PS, Dist- Purulia. After receiving the said information to verify myself along with force (i) C/1224 Gajan Murmu & (ii) C/1250 Jitendra Kumar Dubey both of Barabazar P.S, Dist-Purulia had been to the house of the aforesaid person to the credibility of that information and direction of I.C Barabazar PS reached at about 19:45 hrs found one person was keeping & selling I.D liquor (Cholai). When we reached in front of said place, then seeing the Police party, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking in his house one white colour Plastic Jarikane containing approx 20 (Twenty) liters of I.D liquors (Cholai) and selling from that place. On demand, he failed to produce any valid documents / License in respect of keeping & selling of I.D liquors (Cholai). On being asked he disclosed his identity & confessed his guilt and stated that he selling the ID liquors (Cholai) with intent to sell to make own profit. He also admitted that he had no license or any authorization to keeping and selling of ID Liquor. Accordingly, I seized the above noted article under proper seizure list duly signed by the witnesses and label it. 500 ML of I.D liquor (Cholai) taken as sample from the mother contrabands. The seizure and label was done in between 19.50 hrs to 20.10 hrs.

Thereafter, I secured arrest of the accused Meghnath Mahato @ Honda (33 yrs) S/o Lahur Mahato of Vill-Dumurdih (Bhalukuli), PS-Barabazar, Dist-Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guide line. Informed him and his relatives regarding the ground of arrest. Arrest was made on 20.03.2024 at 20:15 Hrs. I asked the local people as witnesses but none turned up.

Under the above fact & circumstances I, therefore, pray before you that as per law a specific case may kindly be registered against Meghnath Mahato @ Honda (33 yrs) S/o Lahur Mahato of Vill-Dumurdih (Bhalukuli), PS-Barabazar, Dist-Purulia and also for arranging for its investigation.
