Shri Tapan Mandal having is maintaining a savings bank account bearing no. 118801722346 at our Bispuria branch (Branch Code: 07209). On 30.06.2023 at 1.30 pm to 2 pm an amount of Rs. 90,000/- was withdrawn from his account through Voucher slip at SWO counter of our branch. Later Shri Tapan Kumar Mandal gave a complain that he has not withdrawn said amount from his mentioned account on 30.06.2023. On receiving the complaint we scrutinized the transaction as well as CCTV footage and found that an unknown person has withdrawn the amount from his account by forgery of Shri Mandal's signature on voucher slip. The above incident, being a cognizable offence involving public money, we request you to lodge an FIR and to arrange for detailed investigation to probe in

this regard.
