I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act-2007 to the effect that SK. RAJA BABU (PRESENT USER), S/o- Lt. SK. HANIPH, resident at JHALDA KANTADIH, PS- JHALDA, Dist- PURULIA was enjoying electricity unauthorized i.e. Meter Bypass from existing Service Cable due to this reason he has committed theft of electricity U/s 135 (I)/(b) of the electricity (Amendment act-2007) detected on 04.03.2024 at 12.20 PM

Entered the premises of SK. RAJA BABU (PRESENT USER), S/o- Lt. SK. HANIPH, resident at JHALDA KANTADIH, PS- JHALDA, Dist- PURULIA having consumer Id- 242293803, Meter no DDG483443 and inspected his/ her premises. During the inspection theft of electricity was detected i.e. by passing the existing service cable i.e. U/S 135(I)/(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

1. Electrical Bulb- 02 nos.
2. Fan- 01 no.

Out of which I seized the following.

1. PVC two core service cable approx length 06 feet's with bypassing arrangement and one energy meter.

Seizure list was prepared at the site and accused person refused to signed. The inspection team left the premises at 12.40 P.M on 04.03.2024. The accused person has committed an offence U/S 135(I)/(b) of the electricity act-2003 subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
