Sir,

In producing herewith the arrested accused persons namely (i) Rahul Layek (27) S/O Debashish Layek of Jhalda Municipality, Ward No-03, Station road, PS-Jhalda, Dist-Purulia (ii) Dipak Saw (41) S/O Tarapada Saw of Jhalda Anandabazar Bagtipara, Ward No-11, PS-Jhalda, Dist-Purulia (iii) Krisna Saw Kandu (33) S/O Lt. Nimai Saw Kandu of Vill-Mosina, PS-Jhalda, Dist-Purulia & (iv) Jaideep Kumar (32) S/O Lt. Baiju Saw of Vill-Hesmi, PO+PS-Mandar, Dist-Ranchi (Jharkhand) before you, along with seized articles like (i) Board money amounting to RS- 20300/- (40 numbers of 500 rupee notes, 02 numbers of 100 rupee notes & 02 numbers of 50 rupee notes) (ii) 42 pieces of Playing cards (iii) Approx 5 fit/4 fit white colour plastic sheet as per seizure list from a common gaming house i.e. from a hotel named as Apna Hotel located near Sramik Kalyan on Jhalda Ranchi road, PS-Jhalda, Dist-Purulia which is equipped with the sufficient light of

I, ASI Prakash Senapati at 16:35 hrs received a tip off that one gambling with huge amount was going on in a hotel electricity. named as Apna Hotel located near Sramik Kalyan on Jhalda Ranchi road, PS-Jhalda, Dist-Purulia. I noted it in GD book vide GDE No- 281 dated-06/03/24 and informed you and as per your order, I along with force left for working out the information by government vehicle. At about 17:05 hrs, we reached near the hotel and leaving the vehicle, on foot very slowly and cautiously approached towards the hotel where the gambling was reportedly going on. From the outside of said hotel, we heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that, we entered into the hotel at 17:15 hrs and found that 5/6 persons were Grambling by means of playing cards. Seeing Police party they tried to flee away but we were able to detain 04 (four) persons while the other managed to flee. We disclosed our identity and requested them to search me and my other staff but they declined to search us. After that we asked their identity and the persons disclosed their names and addresses as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board i.e. one White plastic placed on the floor and the room of the common gaming house and it was illuminated in with sufficient light of electricity and the playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of money for wrongful loss to one and wrongful gain to another. We searched for the public witnesses but none was available. Subsequently, I seized the following articles such as (i) Board money amounting to RS- 20300/- (ii) 42 pieces of Playing cards (iii) Approx 5 fit/4 fit white colour plastic sheet as per seizure list from a common gaming house i.e. from a hotel named as Apna Hotel located near Sramik Kalyan on Jhalda Ranchi road, PS-Jhalda, Dist-Purulia which is equipped with the sufficient light of electricity after preparing proper seizure list duly signed by the above noted accused persons in presence of the available witnesses in between the 17:35 hrs - 18:15 hrs. The copy of seizure list was supplied to the accused persons. From the accused persons it was learnt that Krishna Krishna Saw Kandu S/O Lt. Kanai saw Jhalda Anandabazar Bagtipara, Ward No-11, PS-Jhalda, Dist-Purulia was present there and he organized the Grambling but seeing Police he fled away.

As the above noted accused persons committed offence punishable u/s- 3 & 4 of West Bengal Gambling and Prize Competition Act, 1957, so I arrested them after informing them the ground of arrest and issued memo of Arrest in respect

Therefore, I pray before you that one specific case may kindly be start under proper section of law against the of each of the above persons. accused persons namely (i) Rahul Layek (27) S/O Debashish Layek of Jhalda Municipality, Ward No-03, Station road, PS-Jhalda, Dist-Purulia (ii) Dipak Saw (41) S/O Tarapada Saw of Jhalda Anandabazar Bagtipara, Ward No-11, PS-Jhalda, Dist-Purulia (iii) Krisna Saw Kandu (33) S/O Lt. Nimai Saw Kandu of Vill-Mosina, PS-Jhalda, Dist-Purulia (iv) Jaideep Kumar (32) S/O Lt. Baiju Saw of Vill-Hesmi, PO+PS-Mandar, Dist-Ranchi (Jharkhand) & (v) Krishna Saw Kandu S/O Lt. Kanai saw Jhalda Anandabazar Bagtipara, Ward No-11, PS-Jhalda, Dist-Purulia and others and arrange its investigation.
