Sir,

In producing here with two arrested accused persons namely (i) Sk. Taimus (42 Years) S/O- Lt. Sk. Sahid of Vill-Purano Jhalda, PS-Jhalda, Dist-Purulia & (ii) Tinku Kumar Das (24 Years) S/O Lt. Sridam Das of Ananda Bazar, Hattola, Ward No-02, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 20 (Twenty) Pcs sealed bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup ONEREEX Cough Syrup @ Rs. 165/- per bottle, having 100 ml in each bottle from the possession of the accused persons mentioned above. I ASI- Subhas Ch. Mahato of Jhalda PS do here by lodged a written complaint against (i) Sk. Taimus (42 Years) S/O- Lt. Sk. Sahid of Vill-Purano Jhalda, PS-Jhalda, Dist-Purulia & (ii) Tinku Kumar Das (24 Years) S/O Lt. Sridam Das of Ananda Bazar, Hattola, Ward No-02, PS-Jhalda, Dist-Purulia to the effect that today (06/03/2024) while performing evening mobile duty (This refers to Jhalda P.S. GDE No- 274 Dt- 06/03/2024, vide C.C. No- 1140 Dt- 06/03/2024) at Jhalda Bus stand, I received an information from my source at about 20:25 hrs that two persons, namely Sk. Taimus & Tinku Kumar Das going towards Jhalda Birshamore side carrying huge quantity of Cough Syrup in a white colour bag for selling clandestinely to the youth customers of Jhalda town area. After having received this information I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I ASI- Subhas Ch. Mahato along with (i) C/1284 Pratapaditya Majhi, (ii) C/1221 Yudhistir Kumar all of Jhalda PS left immediately to work out the information. We, all reached with Govt. Vehicle at Jhalda Bus stand at 20:35 Hrs and found two persons going towards Jhalda Birshamore with a white colour bag as identical as I received information. Subsequently, I apprehended them and search and found (i) 20 (Twenty) Pcs sealed bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup ONEREEX Cough Syrup @ Rs. 165/- per bottle, having 100 ml in each bottle from his bag. On interrogation they disclosed their identities as mentioned above and on demand they failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as signed by the apprehended person and also prepared label with seal and from which 01 (one) bottle of cough syrup was kept as sample. Subsequently, I arrested the accused persons namely (i) Sk. Taimus (42 Years) S/O- Lt. Sk. Sahid of Vill-Purano Jhalda, PS-Jhalda, Dist-Purulia & (ii) Tinku Kumar Das (24 Years) S/O Lt. Sridam Das of Ananda Bazar, Hattola, Ward No-02, PS-Jhalda, Dist-Purulia for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against accused persons namely (i) Sk. Taimus (42 Years) S/O- Lt. Sk. Sahid of Vill-Purano Jhalda, PS-Jhalda, Dist-Purulia & (ii) Tinku Kumar Das (24 Years) S/O Lt. Sridam Das of Ananda Bazar, Hattola, Ward No-02, PS-Jhalda, Dist-Purulia U/S 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
