Sir,

In producing here with Two arrested accused persons namely (i) Suraj Kumar @ Badan Kumar (29 yrs) S/O- Lt. Sunil Kumar of Vill+PO- Chekya, PS- Kotshila, Dist- Purulia and (ii) Haradhan Kumar (24 yrs) S/O- Manbhul Kumar of Vill+PO- Chekya, PS- Kotshila, Dist- Purulia and brought under seizure of the following articles i.e. (i) 25 (Twenty-five) Pcs sealed bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup named as ONEREEX @ Rs. 165.50/- per bottle, having 100 ml in each bottle, (ii) One White colour bag and (iii) One motor cycle having Reg. No. JH10E/5050 from the exclusive possession of the accused persons mentioned above. I, SI Sanjib Kr. Chatterjee of Jhalda PS do here by lodged a written complaint against (i) Suraj Kumar @ Badan Kumar (29 yrs) S/O- Lt. Sunil Kumar of Vill+PO- Chekya, PS- Kotshila, Dist- Purulia and (ii) Haradhan Kumar (24 yrs) S/O- Manbhul Kumar of Vill+PO- Chekya, PS- Kotshila, Dist- Purulia to the effect that today (21/03/2024) while performing evening mobile duty (This refers to Jhalda P.S. GDE No- 1190 Dtd- 21/03/2024 vide C.C. No- 1365/24 Dt- 21/03/2024) at Mosina More, I received an information from my source at about 16:15 hrs that 02 (two) persons are coming from Bakad side towards Jhalda Town by a one motor cycle having Reg. No. JH10E/5050 carrying huge quantity of Cough Syrup in a white colour bag for selling clandestinely to the youth customers of Jhalda town area. After receiving this information, I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I, SI Sanjib Kr. Chatterjee along with (i) C/1221-Yudhistir Kumar, (ii) C/331 Mansaram Kumar & (iii) HG/1827-Sahadeb Singha all of Jhalda PS left Mosina Morh immediately to work out the information. We, all reached with Govt. Vehicle near Gorla more at 17:05 Hrs and found one motor cycle having Reg. No. JH10E/5050 is coming towards Jhalda Town from Baked side. We apprehended them near Gorla more under this PS and searched and found that 02 persons are carrying huge quantity of Cough Syrup in a White colour bag. On its counting it is found as (i) 25 (Twenty-five) Pcs sealed bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup named as ONEREEX @ Rs. 165.50/- per bottle, having 100 ml in each bottle, (ii) One White colour bag and (iii) One motor cycle having Reg. No. JH10E/5050. On interrogation they disclosed their identity as mentioned above and they also said that they collected these illegal cough syrup from Jharkhand state. On demand they failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized (i) 25 (Twenty-five) Pcs sealed bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup named as ONEREEX @ Rs. 165.50/- per bottle, having 100 ml in each bottle, (ii) One White colour bag and (iii) One motor cycle having Reg. No. JH10E/5050 under proper seizure list duly signed by the accompany police personnel as witnesses there was no other local witnesses available right that moment and as well as signed by the apprehended persons and also prepared label with seal and taken sample as 01 (one) bottle of Triprolidine Hydrochloride & Codeine Phosphate Syrup named as ONEREEX. On interrogation they confessed that they were running Cough Syrup (illegal drugs) business and they were carrying the said syrup for the purpose of selling to the local youth customers. Subsequently, I arrested them for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against the accused persons namely (i) Suraj Kumar @ Badan Kumar (29 yrs) S/O- Lt. Sunil Kumar of Vill+PO- Chekya, PS- Kotshila, Dist- Purulia and (ii) Haradhan Kumar (24 yrs) S/O- Manbhul Kumar of Vill+PO- Chekya, PS- Kotshila, Dist- Purulia U/S- 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
