Respected Sir,

In producing herewith 01 (one) arrested accused person namely Milan Mahato (32 yrs) S/o-Baburam Mahato of Vill-Sindri, PS-Purulia(M), Dist-Purulia along with seized one NEW HOLLAND 3032 Blue Colour Tractor without registration number and Engine number, Chassis number rubbed off with trolly loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (01/03/2024) I, SI Gouranga Roy along with (1) C/-1358 Sanjib Kumar Patra (2) NVF/-1860 Suriyakanta Mahato both of Joypur P.S were performing Surprise Naka duty at Sabanpur More under Joypur PS, vide Joypur PS CC No-628 Date-01/03/2024. During Surprise Naka duty at about 15:35 hrs found one Blue Colour Tractor was coming from Uparkahan side under Joypur PS. We stopped the Tractor which was loaded with approx. 100 CFT sand. On integration the driver of the Tractor made incoherent statement at different time. On being asked he disclosed his identity as Milan Mahato S/o-Baburam Mahato of Vill-Sindri, PS-Purulia(M), Dist-Purulia. I asked the driver Milan Mahato to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admitted that he is dealing with illegal sand lifting from Kangsabati riverbed and transporting the sand. The driver also failed to produce any paper in respect of the Tractor. Accordingly, I informed the matter to IC, Joypur PS and as per his direction, I seized the one NEW HOLLAND 3032 Blue Colour Tractor without registration number and Engine number, Chassis number rubbed off with trolly loaded with sand (100 CFT approx) in between 15:45 hrs to 16:05 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested the accused driver Milan Mahato after observing all formalities & disclosed him about the ground of arrest. I brought the said Tractor to Joypur P.S. As such there is every reason to believe that the driver and owner of the tractor is dealing with sand illegally and transporting with ill motive without any valid documents.

Hence, they are liable for offence punishable U/S-379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against driver Milan Mahato (32 yrs) S/o-Baburam Mahato of Vill-Sindri, PS-Purulia(M), Dist-Purulia and owner of the said Tractor may kindly be started and arrange for its investigation.
