Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Srikanta Kumar S/O- Sudhir Kumar (present user) of Vill- Bangora, P.S- Joypur, Dist- Purulia has committed offence U/S 135 (1)(b) of electricity act 2003 subsequently amendment act 2007.

On 12.03.2024 at about 03:15 P.M I, Sri Rabindranath Das (age-46yrs) S/O- Murari Mohan Das, AE & Station Manager, Joypur CCC along with Raushan Kumar, JE(E) Gr-II, Joypur CCC, Ganesh Mahato, Gr-I TSH, Joypur CCC and Shibaram Mahato, Gr-I TSH, Joypur CCC inspected the premises of Srikanta Kumar S/O- Sudhir Kumar of Vill- Bangora, P.S- Joypur, Dist- Purulia and found that Srikanta Kumar S/O- Sudhir Kumar was enjoying electricity unauthorizedly by bypassing the energy meter of Service connection of Sudhir Mahato @Sudhir Kumar S/O- Late Damu Kumar (Vide Meter No. L3885314 Consumer ID: 242171814) and connecting the incoming service line of WBSEDCL to the service mains and bypass the proper registration of units in the energy meter to his residential premises. I prepared inspection report and found physical load as 0.635 kWh i.e. 0.747 kVA.

Upon detection of theft I directed Ganesh Mahato, Gr-I TSH to disconnect the service connection of Sudhir Mahato @Sudhir Kumar S/O- Late Damu Kumar and he disconnected the said service connection with final meter reading 2314 kWh.

As Srikanta Kumar S/O- Sudhir Kumar (present user) committed theft of electricity, I seized the following articles after preparing the seizer list in presence of Raushan Kumar, JE(E) Gr-II, Joypur CCC, Ganesh Mahato, Gr-I TSH, Joypur CCC and Shibaram Mahato, Gr-I TSH, Joypur CCC on which the accused has signed. The inspection team left the premises at 03:40P.M.

Seized Articles are as follows:

01. PVC white colored 2-core 2.5 sq mm aluminum cable 10 mtrs (approx.).

Srikanta Kumar S/O- Sudhir Kumar (present user) of Vill- Bangora, P.S- Joypur, Dist- Purulia has committed an offence U/S 135 (1) (b) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
