Sub: To lodge FIR against Ram Ranjan Kansari S/O Lt Sabar Kansari of Vill - Kashipur, PS - Kashipur, Dist - Purulia, defecto complainant of Kashipur PS Case No 40/23 Dtd 14.03.2023 U/S 420/406/427/511/120B IPC and GR No 166/23.

Sir,

The nub of the fact in a nutshell is that on 14.03.2023 at 13.55 hrs OC Kashipur PS received a court complaint of one Ram Ranjan Kansari S/O Lt Sabar Kansari of Vill – Kashipur, PO – P.K. Raj, PS – Kashipur, Dist – Purulia, duly forwarded by Ld ACJM Raghunathpur Court, to the effect that a civil suit bearing Title suit no 16 of 2017 pending at Civil Judge (Jr Divn) at Raghunathpur in respect of Janata Talkies situated at Mouza – Rangiladih, JL No 31 RS Khatian No 98, RS Plot No 963 total area 34 Decimal under Kashipur PS, Dist – Purulia. On 23.09.2022 one Sri Arun Kr Agarwal S/O Lt Ramniranjan Agarwal of village Kashipur, Madhya Bazar, PS – Kashipur, Dist – Purulia illegally transferred the property of "Janata Talkies" cinema Hall to Anima Beltharia W/O Swapan Kr Beltharia. On 31.10.2022 Sri Arun Kr Agarwal with the help of some other persons forcibly broke some portion of "Janata Talkies" cinema Hall. The alleged person intentionally cheated the complainant by transferring the said property. Over this started Kashipur P.S Case No 40/23 Dtd 14.03.2023 U/S - 420/406/427/511/120B IPC and as per endorsement of O.C Kashipur P.S, SI Jagannath Saha took up investigation of this case.

After collecting available PS records it came to know that previously some cases have been registered by Ram Ranjan Kanasari on the same ground and same Plot No vide Kashipur PS Case No-68/09 Dated- 15.12.09 U/S-447/341/323/506/34 IPC and ended the Case in FRF Vide FRF No - 07/10 Dtd- 10.03.10 and second times Kashipur PS Case No- 47/16 Dated-17.05.16 U/S- 420/406/120B IPC which was ended in FRME Vide FRMF No-56/16 Dtd-28.07.16 and also Kashipur PS Case No 147/22 Dtd 14.12.2022 U/S 406/420/120B IPC which case was ended in FRF vide Kashipur PS FRF No 61/23 Dtd 30.04.2023.

During investigation of Kashipur PS Case No - 40/23 Dated - 14.03.23 U/S - 420/406/427/511/1208 IPC the prima facie charge U/S 420/406/427/511/120B was not established on this case and also revealed that the defecto complainant Ram Ranjan Kansari is a petition monger and always submitted petition here and there and harassed the owners of said land and he registered the case only for taking revenge and the allegation made is totally false and motivated.

After collecting sufficient evidences IO SI Jagannath Saha submitted final Report on this case vide Kashipur PS FRF No - 69/23 Dtd 30 04.23 in this case with a prayer for submitting Prosecution report u/s 211 IPC against the complainant Ram Ranjan Kansari, S/O - Lt Sabar Kansari of Vill - Kashipur, PO - P.K. Raj, PS - Kashipur, Dist - Purulia.

Today i.e. on 06.03.2024 received Order sheet dated 27.02.2024 of Ld ACIM, Raghunathpur Court to the effect that Ld Court is accepted the FRF of this case and also dropped the case and directed to OC, Kashipur PS to draw FIR against the defecto complainant Ram Ranjan Kansari S/O Lt Sabar Kansari of Vill - Kashipur, PS - Kashipur, Dist - Purulia.

Hence, I do hereby lodge this complaint to start a specific case against Ram Ranjan Kansari S/O Lt Sabar Kansari of Vill - Kashipur, PS - Kashipur, Dist - Purulia u/s 211 IPC.
