Sir,

In producing herewith the accused person namely Mantosh Mahato (22 Yrs.), S/O- Ram Chandra Mahato of Vill- Radhutard, Po- Simultard, PS- Kenda, Dist- Purulia A/P Jamtal PS- Kenda Dist-Purulia, and also seized vehicles one Blue colour Tractor having Registration No.-WB 55B /6273 attached with Trolley loaded with sand approx. 100 cft .The fact of the case in brief is that on 03-04/03/2024 I along with C/953 Dulal Ch Mahato and C/3336 Rafik Ansary both of Kenda PS were performing night mobile duty. During Night duty on 03-04/03/2024 at about 00:25 hrs when we reached at near Balakdih High school (Kenda Thana More to Konapara pitch road) under Kenda P.S found that the above noted tractor was coming from Konapara side. On seeing the Police party driver of the said vehicle stopped his tractor in a distance and he tried to flee away after keeping the tractor near at Balakdih High School but we manage to detain the driver of the said tractor. On demand the driver of the said vehicle failed to produce any valid documents in respect of the said tractor and loaded sand. It ascertained that the owner and driver of the said tractor with trolley loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So I seized the Blue colour Tractor having Registration No.-WB 55B /6273 attached with trolley loaded with sand approx. 100 cft. In on 04.03.24 between 00:35 hrs and 00:55 hrs under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver Mantosh Mahato (22 Yrs.), S/O- Ram Chandra Mahato of Vill- Radhutard, Po- Simultard, PS- Kenda, Dist- Purulia of the said tractor at 01:05 hrs after preparing memo of arrest duly signed by the accused driver. I also informed him regarding ground of his arrest and arranged to inform his relatives. There after arrange driver from my source and brought the tractor having Registration No.-WB 55B /6273 attached with trolley loaded with sand approx. 100 cft at Kenda PS. So there have sufficient reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the Blue colour Tractor having Registration No.-WB 55B /6273 attached with Trolley loaded with sand approx. 100 cft.
