2) That the accused persons are dangerous and desperate in nature in nature and they always picked up quarrel with the complainant with some pretext though the complainant tried to adjust and accepted everything the misconduct and behaviour of the accused person in order to maintain peace and harmony in between the two family the complainant never raises any objection or protested the high handed activities of the accused persons.

3) That on 13/11 / 2023 the complainant was reaping paddy on his own Khat at about 11 A.M. at that time the accused persons Gharoud the complainant on his own khat and accused No-1 Sudhir Kumar assaulted the complainant on his head by sword in order to kill him due to previous ~~grudge~~ grudge as a result the complainant sustain bleeding injury then Shakkipada Kumar and Kartik Kumar assaulted the complainant by lathi then the complainant ran away due to fear of life but he did not go to his house and fell down on the ground after going some distance having seen the complainant in such serious condition Papai Thakur along with some Villagers sent the complainant to Kotshila Hospital (B.P.H.C.) in where the doctor of Kotshila B.P.H.C. treated him and thereafter referred him to Purulia Deben Mahato Government Medical Collage and Hospital for better treatment accordingly the complainant admitted there and after treatment the complainant was discharged from the Hospital on 15/11/2023 yet the complainant could not lodge complain on time due to his illness as because he could not pursuit his normal duties .

5) That the complainant informed the matter to the S.P. Purulia even to the O.C. Kotshila again but in vain as such the complainant is compelled to bring this petition before your honours court .

6) That the complainant prays that a through investigation is very much essential in this case .

7) That the accused persons have committed various offences under the Indian penal code .

8) That the complainant is very person and she is not in a position to continue the case on her own capacity .
