Sir,

In producing here with one accused person Subal Gorain (58 Yrs.) S/O Lt- Surjya Narayan Gorain of village- Bhurasole, PS- Manbazar, Dist- Purulia along with seized articles i.e. 17 (Seventeen) Pcs. sealed Bottles of Country Spirit styled as "DIL KHUSH" each bottle containing 600 ML. in which 01 (one) bottle as sample Total 18 X 600 ML. = 10,800 ML. which were seized under proper seizure list.

I S.I. Sanjib Kumar Sen of Manbazar PS do here by lodged a complaint against accused namely Subal Gorain (58 Yrs.) S/O Lt- Surjya Narayan Gorain of village- Bhurasole, PS- Manbazar, Dist- Purulia to the effect that, today (27.03.2024) at 19:15 hrs. I received a telephonic information from a reliable source that one Subal Gorain (58 Yrs.) S/O Lt- Surjya Narayan Gorain of village- Bhurasole, PS- Manbazar, Dist- Purulia has stocked Country Spirit illegally at his Grocery shop at Bhurasole village, PS- Manbazar, Dist- Purulia and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS. myself along with C/1544 Prasenjit Bhattacharjee and C/871 Pranab Kumar Das both are of Manbazar PS rushed to the spot for raid by Govt. vehicle. At about 20:05 hrs. myself along with force reached at Bhurasole village and held raid in the house of Subal Gorain (58 Yrs.) S/O Lt- Surjya Narayan Gorain and found that he is selling the Country Spirit at his Grocery shop. Seeing the police party some persons fled away and said Subal Gorain tried to conceal himself but we were able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling Country Spirit, but he failed to produce any valid license or documents for possessing / selling the same. So I seized the above mentioned articles after preparing proper seizure list duly signed by accused person and available witnesses and arrested the above noted accused person informing the ground of arrest.

Hence, I pray that a specific case may kindly be started against arrested accused person Subal Gorain (58 Yrs.) S/O Lt- Surjya Narayan Gorain of village- Bhurasole, PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
