Respected Sir,

This is to bring in your notice that an incident occurred in the organization (ISPAT DAMODAR PRIVATE LIMITED, Located at Nabagram, P.O - Digha, P.S - Neturia, District - Purulia, West Bengal - 723121) around 06:30 pm of 12th of March 2024 in which a person named Sk Azhar Tanweer S/O Sekh Sahid of Village - Murulia, P.S Santuri, Purulia, West Bengal -723121 was caught red-handed while stealing company properties such as pig iron (approx. weight 25 kgs & approx. amount 38 per INR per kg);, Silco Manganese (approx. weight 45kgs & approx. amount 67 INR per kg), some Iron materials (approx. weight 15kgs & approx. amount 34 INR per kgs) too from Slag Crusher site by doing a hole on the boundary wall to pass the materials outside the premises. Also, he was a loader driver of one of our contractor named M/S Radha Rani Traders so he was allowed to enter the premises to do his job. We were keeping a watch on him as there was a complaint about theft in that area. This brings us notice that that he had an intention of criminal minded activities which directly impacts loss of the organization.

Hence, requesting you to take this an official FIR from the organization and requesting you to please look into this matter. So, in near future this kind of repeated offence can be prevented to avoid such kind of unlawful incident and criminal minded activities.
